Hence, TEC recommended him as technically disqualified bidder.

Further, the Bidder shall also submit an undertaking to the extent that the employees will not be paid less than the remuneration notified under this contract. Hence, TEC recommended him as technically disqualified bidder.
(6/9) M/S MILAN MARINE SERVICE	M/S MILAN MARINE SERVICE . it is observed by TEC that they have submitted all the documents to full fill all technical parameters as mentioned in the tender document except (i)Form 4C: Average Annual Turnover (To be submitted on the letter head of Chartered Accountant / Statutory)with UDIN. Hence, TEC recommended him as technically disqualified bidder.
(7/9) M/S G.A. Digital Web Word Private Limited	M/S G.A. Digital Web Word Private Limited. it is observed by TEC that they have submitted all the documents to full fill all technical parameters as mentioned in the tender document except (i)Blank Performa of Schedule of Prices (ii) Undertaking in regard to clause 3.7 of Section II: ITB. Hence, TEC recommended him as technically disqualified bidder.

(8/9) M/S Singh Erectors Pvt Ltd	M/S Singh Erectors Pvt Ltd. it is observed by TEC that they have submitted all the documents to full fill all technical parameters as mentioned in the tender document except (i)Blank Performa of Schedule of Prices. Hence, TEC recommended him as technically disqualified bidder.
(9/9) M/S HANS ENTERPRISES	M/S HANS ENTERPRISES . it is observed by TEC that they have submitted all the documents to full fill all technical parameters as mentioned in the tender document except (i)Original tender document duly signed in all pages by the bidder (ii)Blank Performa of Schedule of Prices (prices not to be filled) (iii)Similar works (iv)From 4B (v)A signed declaration stating in company letter that salary paid not less than the wages notified under the minimum wages Act of the Government of India. (vi) Undertaking in regard to clause 3.7 of Section II: ITB. Hence, TEC recommended him as technically disqualified bidder.

Digital Web Word Private Limited (viii) M/S Singh Erectors Pvt Ltd (ix) M/S HANS ENTERPRISES have not submitted to fulfill all technical parameters as mentioned in the tender documents. Hence, considering above TEC recommended to all as technically disqualified bidder.TEC also recommended to cancel the tender.
