

Recommendation of TEC on E-tender for "Operation and Maintenance of existing floating/fixed terminals at Silghat on NW-2 (River Brahmaputra) during 2025-26"

3. Observations and Recommendation of TEC

(a) As per the NIT, the tender documents were to be submitted online by the bidder to Director, IWA, Guwahati on or before 02.08.2025 up to 15.00 hrs and to be opened on 04.08.2025 at 15.30 hrs. Accordingly, the technical bids were opened on 05.08.2025. After scrutiny of documents, it is observed by the TEC that 5 (Five) bidders viz. (1/5) **M/s Amar Bora** (2/5) **M/s Mojmul Islam** (3/5) **M/s Rama Shankar Prasad**, (4/5) **M/s Luit Constructions** and (5/5) **M/s G.J.P. Enterprise** have submitted their bids for this tender and the details are as follows: -

(1/5) **M/s Amar Bora** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender except the following:

- (i) EMD & Tender Cost
- (ii) Scanned copy of valid Micro, Small and Medium Enterprises (MSME)/DPIIT certificate for redemption of EMD & Tender cost.
- (iii) Work completion certificate of similar works.

Hence, considering the above TEC recommends to this firm as a technically disqualified bidder.

(2/5) **M/s Mojmul Islam** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender except the following:

- (i) Audit Balance Sheet submitted without seal & sign of C.A. & contractor
- (ii) Profit & Lost Account submitted without seal & sign of C.A. & contractor
- (iii) Submitted Experience Certificate of Less amount.

Hence, considering the above TEC recommends to this firm as a technically disqualified bidder.

(3/5) **M/s Rama Shankar Prasad** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender. Hence, TEC has considered them as a technically qualified bidder.

(4/5) **M/s Luit Constructions** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender. Hence, TEC has considered them as a technically qualified bidder.

(5/5) **M/s G.J.P. Enterprise** has submitted all the requisite documents to fulfill all the technical parameters mentioned in the tender except

- (i) Scanned copy of GST registration certificate.
- (ii) Scanned copy of the labour license from the Concerned Authority.
- (iii) Scanned copy of details of the organisation, its area of function, financial status, and available manpower at least the key personnel etc.

Hence, considering the above TEC recommends to this firm as a technically disqualified bidder.

From the above comparative statement, it is observed that out of three bidders only two bidders are to be technically qualified i.e (3/5) **M/s Rama Shankar Prasad**, (4/5) **M/s Luit Constructions** as they have submitted all the requisite documents to fulfill all technical parameters as mentioned in the tender document and bidders ie. (1/5) **M/s Amar Bora**, (2/5) **M/s Mojmul Islam** & (5/5) **M/s G.J.P. Enterprise** have not submitted all the requisite documents to fulfill all technical parameters as mentioned in the tender document and TEC considered them to be technically disqualified bidders. Hence TEC recommends to open the financial bid of technically qualified bidders.
