

Recommendation of TEC to open the Financial bid for "Dry Dock repair of MV Sam Manekshaw in NW-1 for the F.Y.2025-26" after its technical evaluation.

With reference to the e-tender no. IWAI/VNS/MM(27)/MV Sam Manekshaw/2025-26 a tender was called in to 2 cover system i.e. technical bid & financial bid by IWAI Varanasi vide e-tender ID-2025_IWAI_872949_1. The same was opened on 26.08.2025 at 1500 hrs. Based on evaluation it was found that Eight bidders had participated in the tender for the aforesaid vessel i.e.

1. M/s Dynatron Services Pvt. Ltd., Kolkata.
2. M/s All Hydraulic Service, Delhi.
3. M/s A C ROY SHIPBUILDERS PVT LTD, Kolkata.
4. M/s French Enterprise, Kolkata.
5. M/s GHOSH ENTERPRISE, Howrah.
6. M/s Madheshiya Marines, Howrah.
7. M/s ORTUS CONSULTING SERVICES, Patna.
8. M/s THE SHALIMAR WORKS (1980) LTD, Kolkata.

Upon technical evaluation it was found that four bidders had qualified in the abovesaid tender. The four bidders are as follows:

1. M/s French Enterprise, Kolkata
2. M/s A C ROY SHIPBUILDERS PVT LTD, Kolkata.
3. M/s GHOSH ENTERPRISE, Howrah.
4. M/s THE SHALIMAR WORKS (1980) LTD, Kolkata.

Although M/s french Enterprise Kolkata had submitted all the required necessary documents and technically qualified but as per letter issued by Director, IWAI, Patna vide letter no.12/IWAI/Engg/P(201)2024-25/897, dated 08.09.2025 the firm M/s French Enterprise is debarred/banned for 02 years for Business dealing/ procurement in IWAI.

Hence, in view of above the following three bidders are finally technically qualified (Annex-1) :

1. M/s A C ROY SHIPBUILDERS PVT LTD, Kolkata.
2. M/s GHOSH ENTERPRISE, Howrah.
3. M/s THE SHALIMAR WORKS (1980) LTD, Kolkata.
