

- The offer of L-1 i.e. M/s Damodharte International Pvt. Ltd for lot-II is least cost to MRVC. The overall quoted cost for lot-II is **17.15%** lower than the Estimated Cost. The offer of L-1 is **19.04%** lower than the L-2 (refer para 2.7 above).
- Additional Performance security to be obtained from M/s Damodharte International Pvt. Ltd in terms of ITB 35.5 of the Tender document for an amount of Rs. 99,16,300/- and Rs. 88,45,100/- for Lot-I & Lot-II respectively and to be mentioned accordingly in the LOA.

In view of the above, the rates offered by L-1 i.e. M/s Damodharte International Pvt. Ltd for Lot-I and Lot-II are considered reasonable and acceptable on an overall basis.

4.0. Recommendations

Based on the discussion at Para 2.6 and conclusion at Para 3 above, the following recommendations are made by the TEC:

- to accept the financial offer of M/s Damodharte International Pvt. Ltd., 401-404 Hilton Centre Plot No. 66, Sector 11, CBD Belapur, Navi Mumbai – 400614, for Lot-I at offered cost of Rs.51,26,54,495 (Rupees Fifty one crore twenty six lakh fifty four thousand four hundred ninety five only) excluding Goods and Services Tax (GST) and Rs. 60,49,32,305 (Rupees Sixty crore forty nine lakh thirty two thousand three hundred five only) including Goods and Services Tax (GST) @18% rate. Tenderer will be advised to furnish the additional performance security of Rs. 99,16,300 + 18 % GST as brought out in para 2.6.1.
- to accept the financial offer of M/s Damodharte International Pvt. Ltd., 401-404 Hilton Centre Plot No. 66, Sector 11, CBD Belapur, Navi Mumbai – 400614, for Lot-II at offered cost of Rs. 17,59,23,839/- (Seventeen crore fifty nine lakh twenty three thousand eight hundred thirty nine only) excluding Goods and Services Tax (GST) and Rs.20,75,90,131 (Twenty crore seventy five lakh ninety thousand one hundred thirty one only) including Goods and Services Tax (GST) @18% rate. Tenderer will be advised to furnish the additional performance security of Rs. 88,45,100 + 18 % GST as brought out in para 2.6.1.

5.0. Acceptance

The acceptance/ modifications/ rejection of the Tender Evaluation Report & its recommendations is within the powers of the DT in terms of item 2.01(a) of SOP on works matter of July 2022 (CP-336).
