

Minutes of meeting of Evaluation committee held on 10.02.2025 under the chairmanship of Executive Engineer, NH Division, UPPWD, Varanasi for Financial Evaluation for the work of Short Term Maintenance work on NH 135A (Km 71.984 to 72.684) under the Short Term Maintenance Contract on percentage rate basis for the year 2024-25 under the jurisdiction of NH Div. PWD Varanasi in the State of Uttar Pradesh.

1. The above work has been sanctioned by the Ministry for Rs. 16.28 Lakh vide Job No.-CE-RO/LKO/STMC/135A/Varanasi Division/2024-25/02 dated 27.11.2024 were invited by Executive Engineer, NH Division, UPPWD, Varanasi letter no. 23/13A dt. 08.01.2025 amounting to Rs. 13.01 Lacs (Excluding GST) (amount put tender). The Technical bid were opened on 25.01.2025. The Technical Evaluation Committee meeting chaired by Executive Engineer, NH Division, UPPWD, Varanasi held on 06.02.2025 recommended the following bidders as technical qualified for opening of Financial Bids.

- (i) Smt. Sadhna singh(Contractor), Village-Barahpur Kunwa, Harria, Basti UP
- (ii) M/s Shiv shakti, Village & Post-Uchetha, Badhohi

2. The results of the Technical Responsive bidders were uploaded on the e-tendering portal vide Executive Engineer, NH Division, UPPWD, Varanasi vide office memorandum no. 218/29C dated 07.02.2025.

3. The financial bids were opened on 10.02.2025. The Executive Engineer, NH Division, UPPWD, Varanasi apprised the Evaluation Committee the amount quoted by above 02 (Two) bidders as compared with respect to cost put to tender. The comparative Statement of bid value of each bidder is given below.

Sadhna singh(Contractor), Village-Barahpur Kunwa, Harria, Basti UP for an amount of Rs. 1288423.24 (Twelve Lakh Eighty Eight Thousand Four Hundred Twenty three Rupees and twenty four Paise Only) excluding GST for acceptance towards the award of the instant work.
