2. Accordingly the 1st and 2nd stage evaluation were carried out by the committee on 14.08.2025. The Financial bids were opened by the designated committee and details of financial proposal of qualified bidder are as under:-

3. The committee evaluated the financial proposal and calculated the Financial Score as per Clause 5.3.4 of LOI. The financial scores of proposal will be computed as:

$SF = 100 * (\text{amount equal to 25\% below average bid prices} / \text{bid price of the particular bidder})$

The committee evaluated the combined score as per Clause 5.4 of LOI and Clause 12.4 of data sheet of the RFP. The combined Score of Technical and Financial Score are as per following formula given in RFP:

$S = ST \times T + SF \times f$, Where, S=Combined Score, ST=Technical Score out of 100, SF=Financial Score out of 100

T and f are values of weightage for technical (80%) and financial proposals (20%) respectively as given in the para 12.4 of the Data Sheet.

3.1 The details of combined score and final ranking is as under:

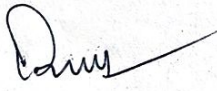

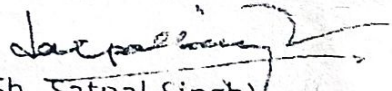
4. The committee in technical evaluation meeting held on 14.08.2025 referred the Ministry's Circular dated 28.08.2024 regarding acceptance of Single bid for National Highway Works and decided that as only one bidder could qualify in 2 stage technical evaluation we shall open financial bid and if price quoted by the single qualified bidder is found reasonable in comparison to market values the shall be accepted and shall be processed for necessary sanction by the Ministry. The single qualified bidder i.e., M/s. M/s CivilMantra Infracon Private Limited in Association with Highraise Construction and Consultant Private Limited quoted amount of Rs. 74,57,627.12/- excluding GST which is within the estimated cost of Rs. 1,00,00,000/-.

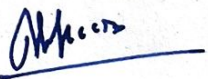
5. After deliberations, the committee recommended obtaining Sanction of the tender based estimate from the Ministry at the quoted rate of M/s CivilMantra Infracon Private Limited in Association with Highraise Construction and Consultant Private Limited. After that, DPR work of "Consultancy Services for Preparation of DPR for 4- Lane from Km 0/0 to Km 15/300 from Punjab Border to Jhalera of NH-503A in the State of Himachal Pradesh" may be awarded to the Most Preferred Bidder (H1) bidder i.e., M/s CivilMantra Infracon Private Limited in Association with Highraise Construction and Consultant Private Limited at his quoted price amounting to Rs. 7457627.12/- excluding GST and Rs. 88,00,000/- including 18% GST).
