**Minutes Of The Technical Bids Evaluation Committee Meeting Held On 15.03.2025

Preamble

The Ministry of Road Transport & Highways, New Delhi has communicated approval to 295 Nos of works amounting to Rs.1385.60Cr vide letter dated:12.03.2024. 19 Works from the approved list were resubmitted to Ministry for according Change of works and to issue fresh approval. Accordingly Ministry vide letter No.P-11/16/2023-RO Bengaluru dated:14.11.2024 has approved the work of "Resurfacing to road from Sira to join AP Border via Pattanayakanahalli gate, Amarapura, Arasikere, Pavagada, Veerupasamudra road from ch: 16.85 km to 27.16 km in Sira taluk" approved under CRIF 2023-24 (Job No. CRF-KNT-2023-24-296) for an amount of Rs.600.00 lakhs and the Secretary, PWD, Govt of Karnataka in the Government order ಸಂಖ್ಯೆ:ಪೋಇ 06 ಸಿ ಆರ್ ಎಫ್ 2024 (ಇ), ಬೆಂಗಳೂರು, ದಿನಾಂಕ: 08.01.2025 has accorded administrative approval.

Technically sanctioned by the Chief Engineer, National Highways, Bengaluru assigning the sanction No. As CER No.161/2024-25, Dated:20.01.2025 for Rs. 600.00 lakhs.

Tender was called for the said work, vide NIT No.04/2024-25, Date:22.01.2025 through CPP portal <https://eprocure.gov.in> .Amount put to tender is Rs.485.44 Lakhs and the calendar of events were as under.

The Technical Bids were opened on 05.02.2025 , 6 bidders have participated in the tender as follows

2. M/s Sheetal Constructions, Bengaluru.
3. M/s H. Narayanappa, Tumkur.

- 4.M/s Sree Kanteshwara Constructions Private Limited, Tumkur.
- 5.M/s MNL & Co, Tumkur
- 6.M/s S.S Policepatil and Company, Dharwad

Only 2 the bidders have submitted original E.M.D within the stipulated date and time of opening of tender as specified in the Notice Inviting tender. Bidder's documents were downloaded and considered for evaluation.

The meeting of the Technical Bid Evaluation committee constituted vide letter dt.31.07.2024 comprising the following members was convened on 15.03.2025 in the chambers of the CE, N.H, Bangalore, to evaluate the technical bids received for the above said work.

The technical bid documents substantiating the qualification criteria indicated in the KW-4 was verified and the committee has resolved the qualification criteria's of bidders as under:

TECHNICAL EVALUATION

1. M/s Jayapraksh Engineers and Contractors, Bengaluru .

The Committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the Committee that bidder has not submitted original E.M.D to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

2. M/s Sheetal Constructions, Bengaluru

The Committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the Committee that bidder has not submitted original E.M.D to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

3. M/s H. Narayanappa, Tumkur

The Committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the Committee that bidder has not submitted original E.M.D to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

4. M/s Sree Kanteshwara Constructions Private Limited, Tumkur

The Committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the Committee that bidder has not submitted original E.M.D to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

5. M/s MNL & Co, Tumkur

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It has been noticed that bidder has submitted (1) the bid security as per clause 13, 2) Annual turnover report as per Clause 3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bank certificates for credit facilities as per clause 3.3b 5) Plant & equipment capabilities as per clause 3.3(a).

The Confirmation pertaining to BG, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents. Hence the documents submitted by the bidder satisfy the conditions as per the Bid Document and is technically responsive.

6. M/s S.S Policepatil and Company, Dharwad

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It has been noticed that bidder has submitted (1) the bid security as per clause 13, 2) Annual turnover report as per Clause

3.2 (a), (3) Work done certificate as a single prime contractor as per clause 3.2(b), (4) bank certificates for credit facilities as per clause 3.3b 5) Plant & equipment capabilities as per clause 3.3(a).

The Confirmation pertaining to BG, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents. Hence the documents submitted by the bidder satisfy the conditions as per the Bid Document and is technically responsive.

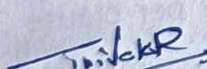
COMMITTEE CONCLUSION:-

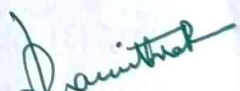

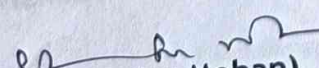
Instructions were issued to the Executive Engineer, National Highway Division, Tumkur to open the financial bids of the responsive bidders as per the departmental procedures.
