Reference is made to RFP application cited above for the subject DPR consultancy assignment. The result of Technical Evaluation was uploaded on CPP Portal on 28.04.2025 and following two bidders were declared technical eligible. All bidders were requested to respond on the result of technical evaluation, if having any objection, within 7 days:

2	M/s K & J Projects Private Limited

2. Thereafter, vide letter dated 02.06.2025 (unloaded on CPP Portal), it was informed that representation were received from the certain bidders regarding the result of technical evaluation. The representations have been deliberated by the Evaluation Committee & noted that, there is no change in Result of Technical Evaluation uploaded on CPP Portal on 28.04.2025. Accordingly, financial proposals of technically qualified bidders were scheduled to be opened on 05.06.2025 at 15:00 hrs. Subsequently, due to administrative reasons, the date of financial openings were postponed to 19.06.2025 at 15:00 hrs.

3. Now the NHAI vide letter No.PROJ-33014/5/2025-PIU Cochin-I dated 17.06.2025 has suspended M/s Highway Engineering Consultant (The Associated partner of ***M/s LN Malviya Infra Projects Private Limited in Association with Highway Engineering Consultant***) from participating in ongoing/future bidding for one month or till completion of investigation of expert committee. Hence, the bid of ***M/s LN Malviya Infra Projects Private Limited in Association with Highway Engineering Consultant*** has been declared non eligible and their financial bid shall not be opened.
