The work "Short Term Maintenance work from km 81 to 88 and Km 98 to 110 and Road Property Maintenance from km 75.00 to 111.00 on NH-123(507) in the state of Uttarakhand." was sanctioned vide Ministry's letter No. RO/UK/STMC/2024-25 (Comp. No. 245786) dated 21.02.2025 for Rs. 494.33 Lakh, (Job. No. RO/UK/STMC/2024-25/05 Dated 21.02.2025. The cost of work proper is Rs. 386.19 Lakh (Excluding GST).
3. The tender for the instant work was invited as per Ministry's Guidelines by the Superintending Engineer, 10th N.H. Circle, PWD, Dehradun vide letter No. 229/13Yata-NH-10/2025 dated 27.01.2025 with online bid submission date as was fixed as 28.02.2025 while opening of online received bids was scheduled on 01.03.2025.

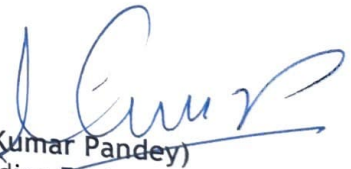
