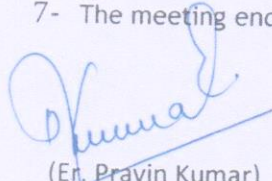
- 1- The work Estimate for reconstruction of damaged Retaining walls, causeway and scupper from km 87.00 to km 122.00 of NH-309 (km 28 (Ramnagar) to km 63.00 (Marchula) of old NH-121 in district Haldwani in the State of Uttarakhand under Emergency Repair 2024-25" was sanctioned vide letter No.RO/UK/SR/2024-25/Haldwani/01 (Com. No. 245946) dt 06-01-2025 for 224.08 Cr.) Job No. (RO/UK/NH-121(New NH-309)/2024-25/702
- 2- The bid for above work was invited through E-tendering by Superintending Engineer, N.H. Circle, PWD, Haldwani vide letter No. 320/12M-NH/2025 dt 27-01-2025.
- 3- The meeting of evaluation committee chaired by Superintending Engineer, NH, PWD, Haldwani on dt.14-02-2025 in the presence of following officers:-

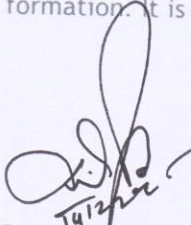
- 4- The financial bids of the technically responsive bidders opened on 14-02-2025 on e-procurement portal. No bidder attended the financial bids opening meeting. The details of quoted bid price as downloaded from e-procurement portal is given below and statement from e-procurement portal is enclosed as Annexure 1 & 2 :-

- 5- Committee found that quoted bid price of Rs 1,14,17,060.69.00 (Rs. One Crore Fourtyeen Lacs Seventeen Thousand Sixty Rupees Pasia Sixty nine Only) by Shri Ram Babu Singh Rampur Road Haldwani is lowest and 15% below from the estimated cost. Thus the committee declared that Shri Ram Babu Singh Rampur Road Haldwani as the selected bidder.
- 6- The committed directed to Superintending Engineer, N.H. Circle, PWD, Haldwani to issue LOA in the name of Shri Ram Babu Singh Rampur Road Haldwani and do the further action for contract formation. It is also directed to take Additional performance security as the bid is 15% below.
