

Minutes of Meeting of Technical Evaluation Committee held on 07.03.2025 in the chambers of Chief Engineer, National Highways, Bengaluru for evaluation of technical bids of “Improvements and Strengthening from Km 300.650 to Km 303.200 & Km 304.380 to Km 306.180, from Km 318.800 to Km 320.400, from Km 324.480 to Km 327.050, from Km 329.300 to Km 330.200 from Km 333.650 to Km 335.650 and Km 335.840 to Km 345.900 on NH-948(209) of D-B section” under One Time Improvement NHAI Deposit Contribution”

Sanctioned cost: Rs.22.083Crores, Civil Construction Cost: Rs. 18.71Crores. (Excluding GST 18%) through Standard Bidding Document (SBD) mode.

Preamble:-

The Regional Officer, National Highway Authority of India, Head Quarters has accorded approval to estimates amounting to Rs. 72.82Cr including 18% GST for improvement of existing road for bypasses/re-alignment stretches in Halaguru, Kanakapura, Harohalli, Chamarajanagara, Santemarahalli, Yelandur, Maddur, Mambally, Kollegala and satteegala town/village limit in Dindigal-Bangalore section of NH-209 in the State of Karnataka under One time improvement for the year 2024-25. The estimate costing to Rs.22,08,32,557.00 has been prepared based on the National Highway Schedule of Rates 2022-23 continued for the year 2024-25 for improvement of bypasses/re-alignment stretches in Chamarajanagara, Santemarahalli, Yelandur, Maddur, Mambally & Kollegala town/village limits.

The technical sanction has been registered in the office of the Chief Engineer, NH, Bengaluru vide CER No. 169/2024-25 Dated:- 29.01.2025.

Accordingly, tender has been invited by the Executive Engineer, NH Division, Bengaluru vide tender Notification No : 12/2024-25 Dated: 30.01.2025.

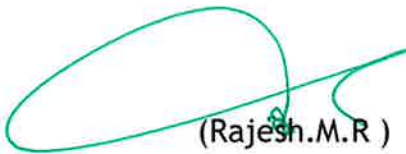
Further, the technical bid evaluation committee concluded the meeting with following instructions to the Executive Engineer, National Highway Division, Bengaluru.

- (i) Publish the technical bid proceedings in the Ministry e- Proc portal and to open the the Financial Bids.
- (ii) An undertaking from the successful bidder has to be obtained for deploying the required machineries and also required Key personals as per IFT at site.
- (iii) An undertaking from the successful bidder that all the required machineries will be kept in good working condition on the site throughout the period of work till

completion along with fitness certificate for the machineries and this undertaking along with the proceedings will become the part of agreement.

- (iv) In case of bidders who have participated in more than one tender the financial bids are to be opened sequentially, based on the bid capacity. The stage at which the bid capacity exhaust, further financial bids of the bidder shall not be open.
