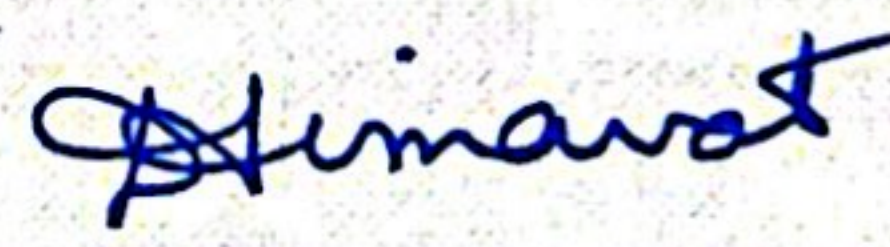
6. In view of the above, Evaluation Committee recommended the opening and evaluation of the financial bid of the above **04 (Four)** technically responsive bidders.

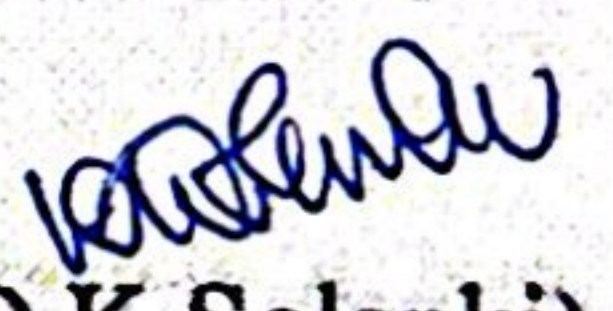
