

Minutes of the Meeting Held on 24.02.2025 to finalize the Technical Evaluation of bids received against “**Short Term Maintenance of NH 309A km Under NH Repair in Year 2024-25 in the State of Uttarakhand**”

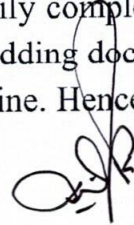

The Project “Short Term Maintenance of NH 309Akm 185.000 to 206.600 Under NH Repair Contract Year 2024-25 in the State of Uttarakhand” was sanctioned vide Ministry’s letter No: RO/UK/STMC/2024-25/01 Dt. 15.01.2025. The cost of work proper is Rs. 368.74 lakh. Excluding 18% GST.

- 1) The bid for the said work was invited as per Ministry’s Guidelines by the Superintending Engineer, NH Circle, Haldwani vide letter no:462/12M-NH/2025 dated 04.02.2025
- 2) The bidding documents relating to the tender were available online at the e-tendering portal of MoRTH <https://morth.eproc.in> from 04.02.2025 up to 19.02.2025 15:00 hrs. The date and time fixed for opening of technical bids was 19.02.2025, 1500 hrs. while the deadline for physical submission of bid security, tender fee and other documents was 18.02.2025, 1100 hrs.
- 3) The physical submission of tender fee, bid security etc. was received from the following bidders: -
 - (a) M/s Balaji Earthmovers, Indra Chowk, Rudrapur
 - (b) M/s Millenium Builders, New Delhi
 - (c) M/s Parihar Construction, Near S.B.I. Takula Road Bageshwar
 - (d) M/s Woodhill Infrastrucure Pvt. Ltd., B-42, RDC Rajnagar, Gaziabad
- (4) The Technical bids were opened online on 19.02.2025 and Three online bids (M/S Balaji Earthmovers, Indra Chowk Rudrapur, M/S Millenium, New Delhi, M/S Parihar construction, Takula Road Bageshwar) were received from the bidders listed above but M/s Woodhill Infrastrucure Pvt. Ltd., B-42, RDC Rajnagar, Gaziabad has bid submitted physically but not submitted online.
- (5) Perusal of the documents submitted by the bidders reveal that the bidder - (i) **M/s Millenium Builders New Delhi** has not submitted satisfactorily completed as a prime contractor for similar Nature work as per Clause 4.3A (b) of bidding document (ii). **M/s Woodhill Infrastructure Pvt. Ltd.** Has not submitted bid online. Hence the above two firm can not be treated as Responsive.

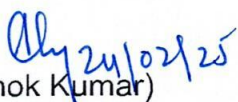


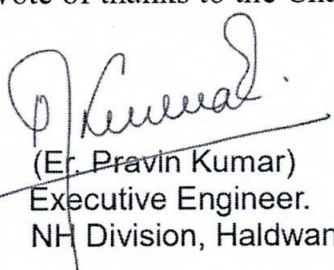


- (6) All the other bidders fulfil all the qualification criteria required by the bidding documents like Turnover requirement, credit facility, one/two/three similar Nature highway projects (Roads) of the required financial value as stipulated in the bid document, bid capacity etc. Therefore, the bids submitted by the remaining two bidders were found to be **technically responsive** to the requirement of the bidding document.
- (7) Therefore, the committee deliberated that the bids submitted by only the following two bidders are technically responsive to the requirement of the bidding document and therefore the financial bids of only these bidders should be opened: -

- a. M/s Balaji Earthmovers, Indra Chowk , Rudrapur.
- b. M/s Parihar Construction Near S.B.I. Takula Road Bageshwar

- (8) The committee recommended the financial bid to be opened on 03.03.2025 at 1500 hrs.
- (9) The meeting ended with a vote of thanks to the Chair.
