

**Minutes of Meeting of Evaluation Committee held on 09.05.2025 under the Chairmanship of Chief Engineer, PWD, NH Zone, Bhopal for the Financial evaluation for the work of:-
Maintenance work from Km 83.79 to Km 137.69 (Sarvardevla to Pal Section) of NH-347C under Short Term Maintenance Contract in the State of Madhya.**

**[Job no: 347C/MP/2024-25/16; Tender ID-2025_MoRTH_847725_1]
Project Cost : Rs. 688.51 Lakhs (Excluding GST)]**

1. The STMC work amounting to Rs. 860.66 Lakh was sanctioned by the Ministry of Road Transport and Highways (MoRTH), Government of India, New Delhi, vide letter dated 17.01.2025.
2. Online bids for the aforementioned work were invited through the e-tendering portal <https://eprocure.gov.in/eprocure/app> by the Chief Engineer (NH), MPPWD, Bhopal, under Tender ID No. **2025_MoRTH_847725_1** dated 05.02.2025.
3. The technical bids were opened on 12.03.2025. A total of **06 (Six)** firms participated and were found responsive as per the evaluation by the committee in its meeting held on 01.05.2025 (Minutes at Annexure-A). The outcome of the technical evaluation was uploaded on the e-tendering portal on 02.05.2025 along with the schedule for opening of financial bids.
4. The financial bids of the 06 responsive bidders were opened and downloaded online on 03.05.2025. As per the bid details downloaded from the CPP Portal (Annexure-B), the results are as follows:-
 - o **PAC: Rs. 688.51 Lakh**
 - o **Bid Due Date: 10.03.2025**

5. The lowest bidder, **M/s. Gayatri Construction**, who quoted Rs. 40684027.54 (i.e., 40.91% below PAC), was subsequently found to be blacklisted.
6. **M/s. Gayatri Construction**, Shivpuri Road, Prayagraj (U.P.), has been blacklisted for a period of 03 years by the Engineer-in-Chief, UPPWD, vide letter no. 3153M.T./General Section/54M-171/2018 dated 06.04.2024 (**copy enclosed**).
7. This blacklisting was further confirmed by the Chief Engineer (National Highways), UPPWD, Lucknow, in communication to the Chief Engineer, North-II, MoRTH, New Delhi, vide letter no. 1197/NII/865N/08 dated 08.04.2024.
8. Accordingly, the Evaluation Committee recommends rejection of the bid submitted by M/s. Gayatri Construction (quoted value: Rs. 40684027.54) and advises that the tender process be re-invited for the said work.
9. As per the MoRTH circular dated 31.08.2022, tenders submitted by blacklisted or debarred contractors are not eligible for acceptance under any circumstances.
10. In accordance with the order issued by the Government of Madhya Pradesh dated 29.12.2005, the Chief Engineer is the competent authority to reject ineligible tenders at the Government level or Engineer-in-Chief level. Therefore, the subject tender is hereby rejected.
11. The Executive Engineer, PWD, NH Division, Indore is instructed to immediately re-invite the tender for the said work. Further, since the financial bid was submitted by a blacklisted contractor prior to the bid due date (10.03.2025), the tender process is deemed to be flawed and objectionable. Accordingly, action is proposed for blacklisting of the concerned bidder as per applicable rules.
