

Revised Minutes of the Meeting of the Evaluation Committee

Held on 18.07.2025 under the Chairmanship of the Chief Engineer (NH Zone), MP PWD, Bhopal, for the Evaluation of Technical Bids for the Work of:-

"Maintenance work of Ambua To Dahod - Section of NH - 56 From Km. 19 to 31, 32 to 35 & Km. 36 To 48/4 Length 29.40 Kms. In the State of Madhya Pradesh Under STMC Work.

Project Cost : Rs. 385.52 Lakh (Excluding GST)

1. The online bids for the aforementioned work were invited through the e-Tendering portal <https://eprocure.gov.in/eprocure/app> by the Chief Engineer (NH Zone), MP PWD, Bhopal, vide Tender ID No. 2025_MoRTH_847732_2, Bhopal, dated 18.06.2025, with the following bid details:-

- Date of Sanction/Cost: 03.02.2025 / Rs.4.70 Cr.
- Project Cost: Rs. 385.52 Lakhs (Excluding GST)
- Bid Due Date: 30.06.2025
- Bid Opening Date: 02.07.2025

2. The technical bids were opened by the Office of the Chief Engineer (NH Zone), MP PWD, Bhopal, on 02.07.2025. Total 03 (Three) firms participated in the tender, as detailed below:-

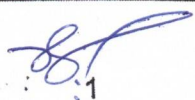
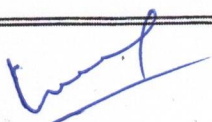

3. The bids uploaded on the e-Tendering portal by all the above-mentioned bidders were evaluated based on the stipulated criteria of the RFP. The result of the technical evaluation was uploaded on the web portal on 07.07.2025. Subsequently, the following bidders submitted representations within the prescribed period of 07 (seven) days from the date of publishing the technical evaluation results:-

- M/s. Shri Buildup Pvt. Ltd. - The bidder submitted a representation dated 13.07.2025; however, the required document was not uploaded as per the terms of the tender. Hence, the bidder has been declared non-responsive.

4. The Evaluation Committee observed that a total of three (03) bidders participated in the bidding process, out of which only two (02) bidder was found to be technically responsive. The details of the evaluation are as follows:-

2. Subsequently, the Financial Bids shall be opened as per the prescribed procedure.

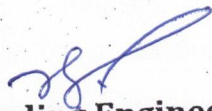
