**Minutes Of The Technical Bids Evaluation Committee Meeting Held On 07-03-2025
In The Chamber Of Chief Engineer, National Highways, Bangalore.**

Name of the Work :-

“One time improvement of Gubbi town from Km.17+500 to 26+000(8.50 Km) of NH-206 Tumkur-Shimogga section in the State of Karnataka under deposit Contribution(NHAI)”.

Preamble

The Executive committee, NHAI (MoRT&H) has examined, finalized and approved the estimate for one time improvement of 40.80 Km reaches in Karnataka costing to Rs. 114.40 Cr vide ref (1). Accordingly the Project Director National Highway Authority of India, PIU Tumkur, has forwarded the estimate amounting to Rs. 28.80 Cr including 18% GST for improvement of Gubbi town from Km.17+500 to 26+000(8.50 Km) of NH-206 Tumkur-Shimogga section in the State of Karnataka under One Time Improvement for the year 2024-25 .

Technically sanctioned by the Chief Engineer, National Highways, Bengaluru assigning the sanction No. as CER No.172/2024-25, Dated:05.02.2025 for Rs. 2880.00 lakhs.

Tender was called for the said work, vide NIT No.05/2024-25, Date:03.02.2025 through CPP portal <https://eprocure.gov.in> .Amount put to tender is Rs.2299.98 Lakhs and the calendar of events were as here under.

The Technical Bids were opened on 01.03.2025 , 5 bidders have participated in the tender as follows

3. Ganapathi Stone Crushers Pvt. Ltd, Class-1 Contractor, Bengaluru.
4. B.M. Manjappa, Class-1 contractor.
5. Balajikrupa projects Pvt. Ltd, Class-1 Contractor.

Only 2 bidders have submitted original E.M.D within the stipulated date and time of opening of tender as specified in the Notice Inviting tender. Bidder's documents were downloaded and considered for evaluation.

The meeting of the Technical Bid Evaluation Committee comprising of the following members was convened on 07.03.2025 in the chamber of Chief Engineer, National Highways, Bengaluru to evaluate the technical bids.

The technical bid documents substantiating the qualification criteria indicated in the Standard Bid document was verified and the committee has resolved the qualification criteria's of bidders as under:

TECHNICAL EVALUATION

1. Sri. H. Narayanappa, Class 1 Contractor, Tumkur.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It has been noticed that bidder has submitted (1) the bid security as per clause 15 and 16, 2) Annual turnover report as per Clause 2.6.3 (a), (3) Work done certificate as a single prime contractor as per clause 2.6.3 (b), (4) bank certificates for credit facilities as per clause 2.6.6 (5) Plant & equipment capabilities as per clause 2.6.5.

The Confirmation pertaining to EMD, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents. Hence the documents submitted by the bidder satisfies the conditions as per the Bid Document and is technically responsive.

2. Sri A. Balaramareddy, Class-1 Contractor, Chitradurrga.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It has been noticed that bidder has submitted (1) the bid security as per clause 15 and 16, 2) Annual turnover report as per Clause 2.6.3 (a), (3) Work done certificate as a single prime contractor as per clause 2.6.3 (b), (4) bank certificates for credit facilities as per clause 2.6.6 (5) Plant & equipment capabilities as per clause 2.6.5.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the committee that bidder has not submitted original E.M.D./Fee to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

5. Balajikrupa projects Pvt. Ltd, Class-1 Contractor.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the committee that bidder has not submitted original E.M.D./Fee to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

COMMITTEE CONCLUSION:-

As the bids submitted by the bidder's Sri. H. Narayanappa, Class 1 Contractor, Tumkur and Sri A. Balaramareddy, Class-1 Contractor, Chitradurga are in line with the uploaded bid documents the committee considered both the bidders as responsive .

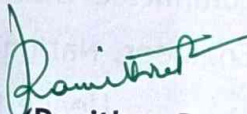

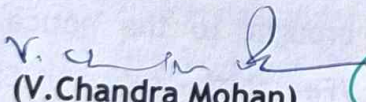
Instructions were issued to the Executive Engineer, National Highway Division, Tumkur to open the financial bids of the responsive bidders as per the departmental procedures.

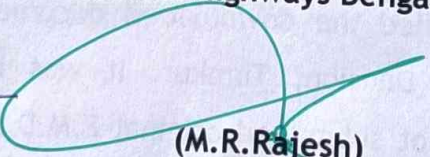

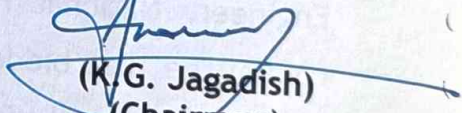
