

MINUTES OF THE DEPARTMENTAL TENDER COMMITTEE HELD ON 6TH MARCH, 2025 AT 4:00 P.M.

IN THE CONFERENCE ROOM OF P.W.D SECRETARIAT, LOWER LACHUMIERE, SHILLONG.

(A) **Bidding Process**:- "Short Term Maintenance Contract (STMC) to Dawki-Amlarem-Jowai Road NH 40E/New NH-206 from Km 214.000 to Km 216.500 (Length=2.500 km) for the year 2023-34 under P.W.D. (Roads) Jowai Central Division in the state of Meghalaya. Job No. RW/GHT/STMC/MG/23-24/6. ***Pre Qualification thereof.***

(i) **Bid Value: Rs.8,12,237.00** (Rupees Eight Lakh Twelve Thousand Two Hundred And Thirty seven) (Inclusive 12% GST & 1% Labour Cess)

First Invitation of tender Consequently upon receipt of sanction from the Ministry of Road Transport and Highway an amount of Rs.9,35,523.00 (Rupees Nine Lakhs Thirty Five Thousand Five Hundred and Twenty Three) only. Vide No. No.RW/GHT/MG/STMC/2023-24 Dated 5.01.2024 for the above project, the RFP for Bidding documents and Notice Inviting Tender were made available in the CPPP, MoRTH of <https://eprocure.gov.in/eprocure/app> from 16th May, 2024 to 11th June, 2024 (upto 14.00 Hrs. IST) and opened on 13th June, 2024, no bidder participated.

However, due to non-participation of bidders, it has to be retendered.

Second Invitation of tender The work was reinvited and RFP were made available in the CPPP, MoRTH <https://eprocure.gov.in/eprocure/app> from 23rd July, 2024 to 13th August, 2024 and was opened on 14th August, 2024, no bidder participated. Again, due to non-participation of bidders, it has to be retendered.

Third Invitation of tender: - The work was again reinvited and RFP were made available in the CPPP, MoRTH <https://eprocure.gov.in/eprocure/app> from 24th September 2024 and the last date of submission of Bids was on 09th October, 2024 (up to 14.00 hours. The Technical bid was opened on 10th October, 2024 (after 14.00 hours IST), only one bidder participated for this project Shri. Nibatskhem Marang.

The Bidder : Shri. Nibatskhem Marang has been considered to be **responsive** bidder. Hence, allowed for opening of Financial Bid.

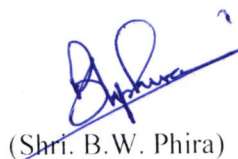
The Financial bid was opened on 11th November, 2024 and the bidder has quoted at the rate of 10% above the cost put to tender amounting to Rs. 9,49,302.20 (Rupees Nine Lakh Forty Nine Thousand Three Hundred Two and paise twenty)only which was considered to be abnormally high bid percentage quoted by the bidder (Corrigendum dated 21st November, 2024) . Therefore, the tender has been cancelled.

Fourth Invitation of tender: - The work was again reinvited and RFP were made available in the CPPP, MoRTH <https://eprocure.gov.in/eprocure/app> from 22nd November, 2024 and the last date of submission of Bids was on 9th December, 2024(upto 14:00 Hrs. IST). The Technical bid was opened on 10th December, 2024 (after 14.00 hours IST) no bidder participated. However, due to non-participation of bidders, it has to be retendered.

Fifth Invitation of tender: - The work was again reinvited and RFP were made available in the CPPP, MoRTH <https://eprocure.gov.in/eprocure/app> from 18th February, 2025 and the last date of submission of Bids was on 3rd March, 2025 (upto 14.00 Hrs IST). The Technical bid was opened on 4th March, 2025 (after 15.00 hours IST).

The technical bid for this project was received both online and in hard copies from only 1(one) bidder i.e. **Shri. Nibatskhem Marang**, based on the documents of the bidder and refers to the Ministry circular EFile No.RW/NH-33044/25/2024-S&R(P&B)(Computer No-240989) dated 28th August, 2024 relating to the Acceptance of Single Bid for National Highways works, the Departmental Tender Committee examined the technical bid of the bidder as per the extant qualification criteria and after a brief discussion, the Committee decided unanimously the following recommendations:

The Bidder : Shri. Nibatskhem Marang has been considered to be **responsive** bidder. Hence, allowed for opening of Financial Bid.
