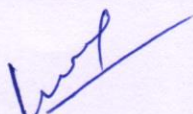

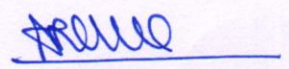
1. The online bids for the aforementioned work were invited through the e-Tendering portal <https://eprocure.gov.in/eprocure/app> by the Chief Engineer (NH Zone), MP PWD, Bhopal, vide Tender ID No. 2025_MoRTH_848463_1, Bhopal, dated 12.02.2025, with the following bid details:-
 - i. Date of Sanction/ Estimated Cost – 03.02.2025 / Rs.1.37 Cr.
 - ii. **Project Cost – Rs. 112.16 Lakhs (Excluding GST)**
 - iii. Bid Due Date – 10.03.2025
 - iv. Bid Opening Date – 12.03.2025
2. The technical bids were opened by the Office of the Chief Engineer (NH Zone), MP PWD, Bhopal, on 21.03.2025. Total 05 (Five) firms participated in the tender, as detailed below:-

3. The bids uploaded on the e-Tendering portal by all the above-mentioned bidders were evaluated based on the stipulated criteria of the RFP. The result of the technical evaluation was uploaded on the web portal on 28.05.2025. Subsequently, the following bidders submitted representations within the prescribed period of 07 (seven) days from the date of publishing the technical evaluation results:-
 - **M/s. Narayandas Phoolchand Mishra Infrastructure Pvt. Ltd.,** submitted a representation dated 02.06.2025. However, the bidder did not submit all the required documents before the bid due date. Accordingly, the Committee has decided to declare the bidder as Non-Responsive.
 - **M/s. Dynamic Electricals and Switchgear Pvt. Ltd., Noida,** submitted a representation dated 29.05.2025. However, the bidder did not submit all the required documents before the bid due date. Accordingly, the Committee has decided to declare the bidder as Non-Responsive.
 - **M/s Subhash Chandra Dilliwal Contractor,** submitted a representation dated 02.06.2025. However, the bidder did not submit documentary evidence of having executed work of a similar nature. Accordingly, the Committee has decided to declare the bidder as Non-Responsive.







4. The Evaluation Committee observed that a total of five (05) bidders participated in the bidding process, out of which only one (01) bidder was found to be technically responsive. The details of the evaluation are as follows:-

5. **Conclusion:-**

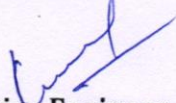
The Evaluation Committee reviewed the representations and concluded that one (01) bidder was found to be technically responsive, in accordance with the criteria specified in the tender document.

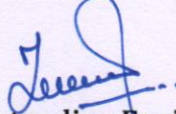
Accordingly, it was decided that:-

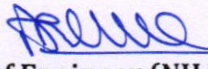
1. The outcome of the Technical Evaluation shall be published on the web portal.

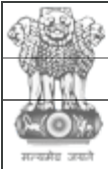

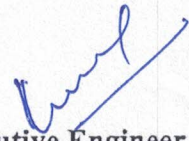
