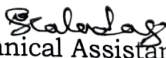

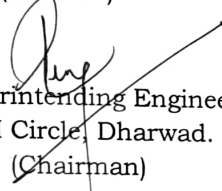
After detailed verification of the documents w.r.t. above qualification criteria the Executive Engineer has tabulated the Responsive and Non responsive bidders.
