

Minutes of Meeting of the Evaluation Committee
Held on 16.06.2025 under the Chairmanship of Chief Engineer (NH Zone), MPPWD, Bhopal
For Evaluation of Financial Bid for the Work of:-

“Maintenance work from Km 01 to Km 26 in Multai-Warud section of NH 347A (Length 25.00km) under short Term Maintenance Contract in the state of Madhya Pradesh.”

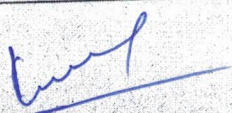

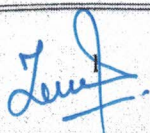
1. The online bids for the aforementioned work were invited through the e-Tendering portal <https://eprocure.gov.in/eprocure/app> by the Executive Engineer, MP PWD, NH Division, Indore, vide Tender ID No. 2025_MoRTH_848871_1, dated 12.02.2025, with the following bid details:-
 - i. Date of Sanction/ Estimated Cost – 03.02.2025 / Rs.4.88 Cr.
 - ii. Project Cost – Rs. 399.998 Lakh (Excluding GST)
 - iii. Bid Due Date – 10.03.2025
 - iv. Bid Opening Date – 12.03.2025
2. The Technical bid were opened on 17.03.2025. The Evaluation Committee observed that a total of seven (07) bidders participated in the tender process. Out of these, only one (01) bidder was found to be technically responsive. The technical evaluation results are as follows:-

3. The financial bid of the technically responsive bidder was opened on 12.06.2025. Details are as follows:- (Estimated Cost: Rs. 4.88 crore):

4. As per the financial bid evaluation, M/s. Rajdeep Construction Compnay Betul has emerged as the L-1 bidder, with a quoted amount of Rs. 3,59,55,787.86/- (Rupees Three-Crore Fifty-Nine Lakh Fifty-Five Thousand Seven-Hundred Eighty-Seven Only), which is 10.11% below the PAC (exclusive of GST).

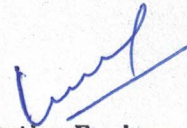
Conclusion:-

1. "As per the order issued by the Govt. of MP, PWD dated 28.01.2013, a single bid may also be opened provided adequate publicity has been ensured, in accordance with the prescribed rules. The matter may be examined by the competent authority for an appropriate decision."
2. The Evaluation Committee has found the financial bid of M/s. Rajdeep Construction Company, Betul, quoting Rs. 3,59,55,787.86 (Rs. Three Crore Fifty-Nine Lakh Fifty-Five Thousand Seven-Hundred Eighty-Seven Only), which is 10.11% below the sanctioned civil cost, to be the lowest bid (L-1).
3. The received bid is a single bid, with a quoted rate of 10.11% below the sanctioned civil cost. Since the rate of the received single bid is higher than the prevailing tender rate, the committee has decided to reject it. Furthermore, the Executive Engineer, MP PWD, NH Division, Indore, has been directed to recall the tender at the earliest.

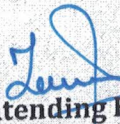
