2. The technical bids were opened by the Office of the Chief Engineer (NH Zone), MP PWD, Bhopal, on 17.03.2025. Total 07 (seven) firms participated in the tender, as detailed below:-

3. The bids uploaded on the e-Tendering portal by all the above-mentioned bidders were evaluated based on the stipulated criteria of the RFP. The result of the technical evaluation was uploaded on the web portal on 28.05.2025. Subsequently, the following bidders submitted representations within the prescribed period of 07 (seven) days from the date of publishing the technical evaluation results:-

- M/s. Dynanic Electricals and Switchgear Pvt. Ltd., Noida, submitted a representation dated 29.05.2025. However, the bidder did not submit all the required documents before the bid due date. Accordingly, the Committee has decided to declare the bidder as Non-Responsive.

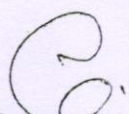
5. **Conclusion:-**

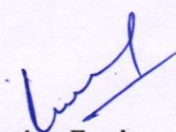
The Evaluation Committee reviewed the representations and concluded that one (01) bidder was found to be technically responsive, in accordance with the criteria specified in the tender document.

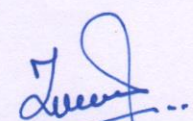
Accordingly, it was decided that:-

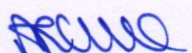
1. The outcome of the 0 Evaluation shall be published on the web portal.

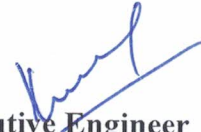

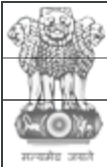
