

Revised Minutes of the Meeting of the Evaluation Committee

Held on 18.07.2025 under the Chairmanship of the Chief Engineer (NH Zone), MP PWD, Bhopal, for the Evaluation of Technical Bids for the Work of:-
“Maintenance work from Km 01 to Km 26 in Multai-Warud section of NH 347A (Length 25.00km) under short Term Maintenance Contract in the state of Madhya Pradesh.”

- The online bids for the aforementioned work were invited through the e-Tendering portal <https://eprocure.gov.in/eprocure/app> by the Chief Engineer (NH Zone), MP PWD, Bhopal, vide Tender ID No. 2025_MoRTH_848871_2, Bhopal, dated 18.06.2025, with the following bid details:-
 - Date of Sanction/Cost: 03.02.2025 / Rs.4.88 Cr.
 - Project Cost: Rs. 399.998 Lakhs (Excluding GST)
 - Bid Due Date: 30.06.2025
 - Bid Opening Date: 02.07.2025
- The technical bids were opened by the Office of the Chief Engineer (NH Zone), MP PWD, Bhopal, on 02.07.2025. Total 03 (Three) firms participated in the tender, as detailed below:-

- The bids uploaded on the e-Tendering portal by all the above-mentioned bidders were evaluated based on the stipulated criteria of the RFP. The result of the technical evaluation was uploaded on the web portal on 07.07.2025. Subsequently, the following bidders submitted representations within the prescribed period of 07 (seven) days from the date of publishing the technical evaluation results:-

- M/s. Ramraja Construction Co.** - The bidder submitted a representation dated 14.07.2025, however, the required document was not uploaded as per the terms of the tender. Hence, the bidder has been declared non-responsive.

- The Evaluation Committee observed that a total of three (03) bidders participated in the bidding process, out of which only two (02) bidder was found to be technically responsive. The details of the evaluation are as follows:-

The Evaluation Committee reviewed the representations and concluded that two (02) bidder was found to be technically responsive, in accordance with the criteria specified in the tender document.

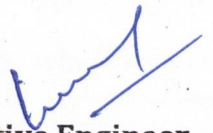
Accordingly, it was decided that:-
