MINUTES OF MEETING OF TENDER EVALUATION COMMITTEE HELD ON 06.06.2025 FOR CONSIDERATION OF TECHNICAL BID FOR THE WORK OF "ONE TIME IMPROVEMENT OF DIVERTED ROAD OF OLD ALIGNMENT FROM KM 5.70 TO KM 19.60 OF OLD NH-44A (NEW NH-108) IN THE STATE OF MIZORAM" (JOB NO.44/MZ/2023-24/123)

The work under consideration was sanctioned by the Ministry amounting to ₹ 10.83 crore vide No. NH-12014/124/2023-RO Guwahati Dated 18th December 2024. The estimated civil construction cost of work is ₹ 8.61 crore. The work is proposed under EPC mode as per Ministry's laid down procedures.

2. As per Ministry's Circular No.RW/NH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018 for the works with sanction cost more than ₹ 5.00 to ₹ 100.00 crore, tender may be invited by the State PWD using requisite bidding document and procedure as per Ministry's extant guidelines.
