**Minutes Of The Technical Bids Evaluation Committee Meeting Held On 13-03-2025
In The Chamber Of Chief Engineer, National Highways, Bangalore.**

Name of the Work :-

"One-time improvements to road in town limits of Palya, Ballupete and Sakaleshapura on NH-75 in Hassan district in Karnataka under deposit Contribution(NHAI)".

Preamble

The Executive committee, NHAI (MoRT&H) has examined, finalized and approved the estimate for one time improvement of 40.80 Km reaches in Karnataka costing to Rs. 114.40 Cr vide Minutes of 649th meeting of Executive Committee held on 16.01.2025 at 11.30am at NHAI HQ. Accordingly the Project Director National Highway Authority of India, PIU Hassan, has forwarded the estimate amounting to Rs. 10.06 Cr including 18% GST for One-time improvements to road in town limits of Palya, Ballupete and Sakaleshapura on NH-75 in Hassan district in Karnataka.

Technically sanctioned by the Chief Engineer, National Highways, Bengaluru assigning the sanction No. as CER No.173/2024-25, Dated:14.02.2025 for Rs. 1006.47 lakhs.

Tender was called for the said work, vide NIT No.13/2024-25, Date:17.02.2025 through CPP portal <https://eprocure.gov.in> .Amount put to tender is Rs.2299.98 Lakhs and the calendar of events were as here under.

The Technical Bids were opened on 10.03.2025 , 3 bidders have participated in the tender as follows

1. Shri. Rajesab I Banagar, Class 1 Contractor, Haveri.
2. M/s.Rayeegowda, Class-1 Contractor, Channarayapattana.
3. Shri.Ramesh Kumar Kothari, Class-1 Contractor, Hassan.

Only 2 bidders have submitted original E.M.D within the stipulated date and time of opening of tender as specified in the Notice Inviting tender. Bidder's documents were downloaded and considered for evaluation.

The meeting of the Technical Bid Evaluation Committee comprising of the following members was convened on 13.03.2025 in the chamber of Chief Engineer, National Highways, Bengaluru to evaluate the technical bids.

The technical bid documents substantiating the qualification criteria indicated in the Standard Bid document was verified and the committee has resolved the qualification criteria's of bidders as under:

TECHNICAL EVALUATION

1. Shri. Rajesab I Banagar, Class 1 Contractor, Haveri.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Hassan. It has been noticed that bidder has submitted (1) the bid security as per clause 16 of section-1, 2) Annual turnover report as per Clause 2.6.3 (a), (3) Work done certificate as a single prime contractor as per clause 2.6.3 (b), (4) bank certificates for credit facilities as per clause 2.6.6 (5) Plant & equipment capabilities as per clause 2.6.5.

The Confirmation pertaining to EMD, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents. Hence the documents submitted by the bidder satisfies the conditions as per the Bid Document and is technically responsive.

2. M/s.Rayeegowda, Class-1 Contractor, Channarayapattana.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It has been noticed that bidder has submitted (1) the bid security as per clause 16 of section-1, 2) Annual turnover report as per Clause 2.6.3 (a), (3) Work done certificate as a single prime contractor as per clause 2.6.3 (b), (4) bank certificates for credit facilities as per clause 2.6.6 (5) Plant & equipment capabilities as per clause 2.6.5.

The Confirmation pertaining to EMD, Work done and Line of Credit has been obtained and is in line with the submitted Bid documents. Hence the documents submitted by the bidder satisfy the conditions as per the Bid Document and is technically responsive.

3. Shri.Ramesh Kumar Kothari, Class-1 Contractor, Hassan.

The committee verified the downloaded documents as furnished by Executive Engineer, National Highway Division, Tumkur. It was brought to the notice of the committee that bidder has not submitted original E.M.D./Fee to the office of Executive Engineer, National Highways Division, Tumkur.

Hence the Technical bid was not considered for the evaluation and is technically non responsive.

COMMITTEE CONCLUSION:-

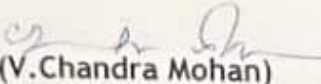

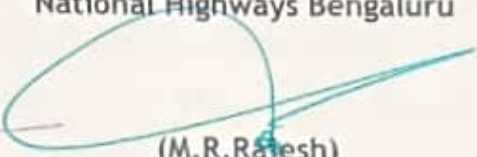
Instructions were issued to the Executive Engineer, National Highway Division, Hassan to open the financial bids of the responsive bidders as per the departmental procedures.

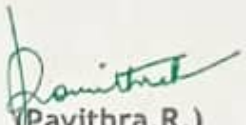
