

Revised Minutes of Meeting of Evaluation Committee

Minutes of Meeting of Evaluation Committee held on 14.07.2025 under the Chairmanship of Chief Engineer-PWD. NH. Zone, Bhopal for the technical evaluation for the work of "Maintenance work from km 327.00 to km 360.00 Jaura-Morena section of NH 552 Extn under Short Term Maintenance Contract for the financial year 2024-25 in the State of Madhya Pradesh."

- The online bids for above mentioned work were invited through e-tendering Portal <https://eprocure.gov.in/eprocure/app> by CE (NH), MPPWD, Bhopal vide Tender ID no. **2025_MoRTH_849815_1** Bhopal, dated 07.03.2025 with following bid details: -
 - Date of Sanction / Cost: **17.01.2025 / Rs. 509.44 Lakh**
 - Project Cost: Rs. 509.44 Lakhs (Excluding GST)**
 - Bid due date -**15.04.2025**
 - Bid opening date - **17.04.2025**
- The technical bids were opened by Office of The CE (NH), MPPWD, Bhopal on 17.04.2025. Following 08 nos. of firms have participated in the tender: -

- The bids uploaded on the e-Tendering portal by all the above-mentioned bidders were evaluated based on the stipulated criteria of the RFP. The result of the technical evaluation was uploaded on the web portal on 17.05.2025. Subsequently, the following bidders submitted representations within the prescribed period of 07 (seven) days from the date of publishing the technical evaluation result: -
 - M/s Bhagwati Enterprises, Morena (M.P.)**, submitted a representation dated 23.06.2025, along with a scanned copy of documentary evidence regarding the extension of the bank guarantee but bid security is not valid for 165 days (45 days from the bid validity) from the original bid due date i.e. 24.05.2025 and therefore the bid is considered as non-responsive as per para 16.2 of the RFP.
 - M/s MK Developers & Infrastructure, Gwalior (M.P.)**, submitted a representation dated 24.06.2025, providing documentary evidence regarding the extension of the bank guarantee but bid security is not valid for 165 days (45 days from the bid validity) from the original bid due date i.e. 24.05.2025 and therefore the bid is considered as non-responsive as per para 16.2 of the RFP.
 - M/s Tomar Builders and Contractors Private Limited, Gwalior (M.P.)**, submitted a representation dated 18.06.2025, providing documentary evidence regarding the extension of the bank guarantee but bid security is not valid for 165 days (45 days from the bid validity)

 - **M/s Vijay Kumar Jain**, Bidder has not submitted the experience certificate as per RFP clause 4.3b of Section 2 Instructions to Bidders. Therefore, the bidder is disqualified from the tender.
 - **M/s Tulsi Narayan Garg, Sheopur (M.P.)** *debarred for 02 year from participation in future tenders by GM MPRRDA Sheopur vide letter no. 1168/MPRRDA//2024/MP37603 Sheopur dated 17.09.2024 under clause 52 of the agreement, and contractor in its undertaking didn't mention the debarment details. Therefore the bid is considered as non-responsive as per clause 4.5 of the RFP.*

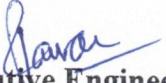
5. **Conclusion: -**

2. Subsequently, the Financial Bids shall be opened as per the prescribed procedure.

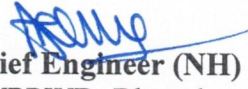
