The work "Estimate for Construction of Damage R/Wall ,B/Wall on NH534(119) from km 27.00 to 80.00 under Emergency Repair 2024-2025 in the State of Uttarakhand" was sanctioned vide Ministry's letter No. RO/UK/SR/2024-25/Dhumakot/02 (com.no.247024) Dated 18.02.2025 for Rs. 4.97 Cr, (Job. No. RO/UK/NH-534(119)/2024-25/711. The cost of work proper is **Rs. 3.88 Crore** (Excluding GST).

3. The tender for the instant work was invited online as per Ministry's Guidelines by the Superintending Engineer, 10th N.H. Circle, PWD, Dehradun vide letter No. 622/13 Yata-Rama-10/2025 dated 24.02.2025. The bid due date was 24.03.2025 and opening date of bids was scheduled on 25.03.2025.

4. Member secretary informed that 08(Eight) bidders submitted the requisite physical tender documents as per the conditions of the Tender Notice & Instructions to bidders of SBD. Hence technical bid of the following 08 (Eight) bidders were declared Responsive for opening of their technical bid online on Dt 25.03.2025.

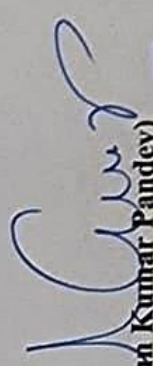
