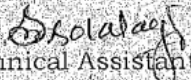

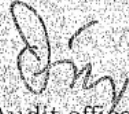

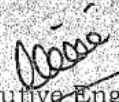
With the above details the technical bids of the said Two bidders have been placed before the technical bids evaluation committee the Member Secretary for kind approval.
