1. The instant work was granted Administrative Approval and Financial Sanction vide Ministry's letter no. NH/15017/64/2024/P&M dt.11.02.2025 amounting to Rs. 4.58cr (i/c GST). Technical sanction was issued vide letter no. RW/NH/STMC/2024-25/RO-Ita/14526-27 dt. 13.02.2025 amounting to Rs. 4.58 cr. (i/c GST).

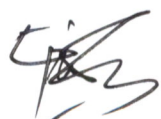
2. The work was bid out in two cover bid system through e-procurement on 11.03.2025 and the technical bids were opened on 19.03.2025.

3. The evaluation committee examined the document placed before the committee. Evaluation sheet is enclosed at Annex-I. Based on the evaluation; the committee observed the following:

3.1. BHARAT VANIJYA EASTERN PVT. LTD: The committee found the bidder to be **Technically Responsive** as per Clause 4 and 26 of the RFP.

3.2. Ms Amun Motor Parts and Engineering Works.: The committee observed the following: Bidder has not furnished details for calculating of Bid capacity required as per Clause 4.4 Section-2 of the RFP. Also, bidder has not submitted any eligible projects for similar work in highways as required as per clause 4.3(A)b(iv) of Section-2 (ITB) of the RFP. Bidder has not furnished experience details for Project Manager, Site Engineer-cum-Surveyor Engineer cum Route Operation Manager and incident cum property manager as required as per Appendix to ITB Cl- 4.3 B(b)(ii) of RFP. Hence, the committee has found the bidder to be **Technically Non-Responsive** as per Clause 4.4, 4.3(A)b(iv) of Section-2(ITB) of the RFP and 4.3 B(b)(i)(ii), Appendix to ITB, Section-3 of RFP.

3.3 Ms Y 2 Enterprises: - The committee observed the following: Bidder has not furnished the report on financial standing required as per Cl-4.1(f) of Section-2 of the RFP. Hence the committee has found the bidder to be **Technically Non-Responsive** as per Cl-4.1(f) of Section-2 of the RFP.



3.5 Ms. GRRB ASSOCIATES: - The committee observed the following: Bidder has not furnished requisite number of Dewatering Pump as required as per Cl-4.1(d) & Appendix to ITB Cl- 4.3 B(b)(i), Section - 3 of RFP. Hence the committee has found the bidder to be **Technically Non-Responsive** as per Cl-4.1(d) and Appendix to ITB, Cl- 4.3 B(b)(i), Section - 3 of RFP of RFP.

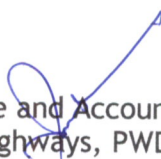
3.6 N M Enterprises: - The committee observed the following: * Bidder has not furnished the undertaking required as per Cl-4.1(h) of RFP. Hence the committee has found the bidder to be **Technically Non-Responsive** as per Cl-4.1(h) of Section-2 of the RFP.

3.7 PUNA HINDA.: - The committee observed the following: Bidder has not furnished the details of "On-going CRIF C/o Road with Bridge from Chayangtajo Yangfo road (from Sangri-Sangda under Chayangtajo Circle to Wacha-Holling (Veo) Sanglowa Bagang, Tawara Yangfo & Dadra under Sawa Circle on Indo-China Border (L = 35.00 km) (Ph-I-0.00 to 4.00 km)" under existing commitments. This is hiding of information, misleading and false representation as per Cl-4.5(i) of RFP. Further, bidder has not furnished the undertaking required as per Cl-4.1(h) of RFP. Hence the committee has found the bidder to be **Technically Non-Responsive** as per Clause 4.5(i) and 4.1(h) of Section-2 of the RFP.

3.8 AAKSHYA INFRA PROJECTS PRIVATE LIMITED.: - The committee found the bidder to be **Technically Responsive** as per Clause 4 and 26 of the RFP.

4. In view of the above, the committee found 2(two) bidders to be technically responsive and recommended for opening their financial proposals for the work of "**Repair and Maintenance works on Namchik-Miao-Vijaynagar Road (NH 913) from 23rd Mile to Burma Nallah (Length -23.600 Km) under STMC in the state of Arunachal Pradesh.** [JobNo: RW/ ITA/ STMC/Ar.Pr./ 2024-25/NMV/03]"
