Minutes of Meeting of Financial Bid Evaluation held on 07.05.2025 under the Chairmanship of Chief Engineer Highways Zone, Itanagar, PWD

As per the Minutes of meeting held on 01.04.2025, the Evaluation Committee had recommended to open the financial bids of 2 (two) technically responsive bidders. The result of technical evaluation was displayed on e-procurement portal on 25.04.2025 for 07 days as per Clause 23.5 of the RFP. One bidder M/s Hachang Tachang represented to declare the firm as Technically Responsive. The Evaluation Committee deliberated on the representation and found no merit in it, thereby upholding the technical result as per the 1st meeting dt. 01.04.2025. The date of financial opening was fixed on 07.05.2025.

2. Accordingly, the financial bids of eligible bidders were opened on 07.05.2025 at 17:00 hrs. The details of financial quotes submitted by the eligible bidders are as under:

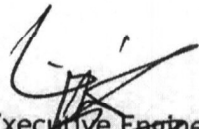

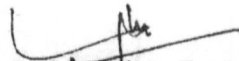

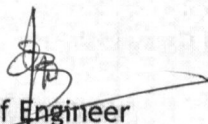
3. Based on the amount quoted by the bidders, the price bid of AAKSHYA INFRA PROJECTS PRIVATE LIMITED is found to be the lowest (L1) which is 1.50% below the estimated cost put to tender.

In view of the above, the evaluation committee accepts the price quoted by the L-1 bidder and recommended to award the work of "Repair and Maintenance works on Namchik-Miao-Vijaynagar Road (NH 913) from Burma Nallah to 62nd Mile (Length - 24.600 Km) under STMC in the state of Arunachal Pradesh. [Job No: RW/ITA/ STMC/ Ar.Pr./2024-25/NMV/04]" to the selected L-1 bidder AAKSHYA INFRA PROJECTS PRIVATE LIMITED at the quoted bid price of Rs. 3,90,00,647.00/- (**Rupees Three Crore Ninety Lakh Six Hundred and Forty-Seven Rupees Only**) subject to submission of performance security in the form set forth in Section-4 of RFP for an amount of Rs. 3,95,000/- (**Rupees Three Lakh Ninety-Five Thousand Rupees only**) and other documents as listed under Clause-12.2, Section 2 of the RFP.
