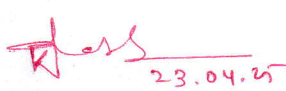

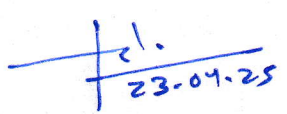

In response, the bidder vide his letter no. 03/2025-26, dated 21.04.2025 has submitted his un-willingness to execute the above work in the lowest rate quoted by L1 bidder i.e. equal to the estimated amount put to tender.

22. Validity of Bid :- The validity of the Bid is up to 03.07.2025 (i.e. 90 days)
23. Recommendation of Committee :- Based on the price quoted by L1 bidder Sri Ashok Kumar Mohapatra and un-willingness submitted by L2 bidder Mukesh Jhankar (S.T) the committee unanimously decided to verify the original documents of L1 bidder Ashok Kumar Mohapatra, 'B' Class Contractor & issue Letter of acceptance (L.O.A) as per clause no. 37 of DTCN .
