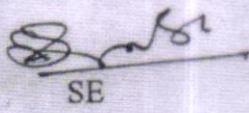

The Superintending Engineer, NH Central Circle invited tender through the MoRTH e-procurement portal keeping the start date of online bid submission on 28/05/2025 and last date of bid submission on 5/06/2025. Three bids were received online and opened bids on 16/06/2025. M/s Manglam Infra& Engineering Ltd , M/s Civil Mantra Infracon Pvt. Ltd & M/s MAPS GLOBAL CIVILTECH Pvt.Ltd are the three bidders. As per the Technical bid opening committee dated 16/06/2025 it was decided to reject the bid submitted from M/s Civil Manthra Infracon Pvt.Ltd since not submitted the Bank Guarantee towards EMD,Tender fee & GST. The remaining bids M/s Mangalam Infra & Engineering Ltd & M/s MAPS GLOBAL CIVILTECH Pvt.Ltd are admitted for detailed scrutiny and Technical Evaluation,

The Evaluation is going on but mean while as per decision on the meeting of the committee (clause 3.1.3 of Minutes) for approval of alignment of Capacity Augmentation of NH 183 from Km 106/700 to Km 137/000(Kottayam to Mundakkayam) which was held on 6/08/2025 under the chairmanship of DG

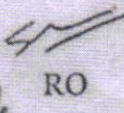

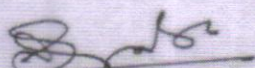

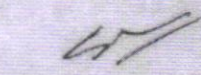
