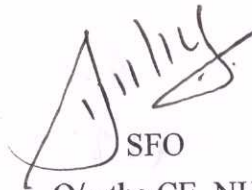

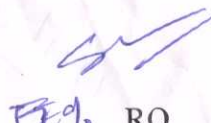

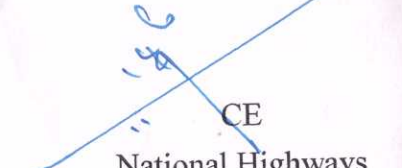

Three bids were received online. The following are the bidders.

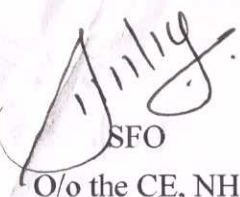

The committee opened the bids received online. M/s MAPS GLOBAL CIVILTECH Pvt.Ltd submitted the Bank Guarantee towards EMD, Tender fee and GST. But M/s ManglamInfra & Engineering Ltd and M/s Civil Mantra Infracon Pvt. Ltd were not submitted the Bank Guarantee towards EMD, Tender fee and GST.The consultancies produce 'UDYAM REGISTRATION CERTIFICATE" for exemption towards EMD, Tender fee and GST.But in RFP published for this work there is no clause in connection with fee exemptions for MSME's.

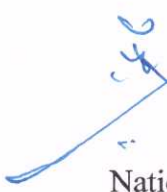
As per.G.O(P) No.1/2021/FIN dated 03/01/2021 Finance (Industries & PUBLIC WORKS -B) DEPARTMENT, states that exemption regarding EMD/ Security Deposit /Performance Gurantee granted to MSMEs is not applicable for Civil/Electrical/ Infrastructure Contracts.

Hence , Committee decided to reject the bids submitted from M/s Manglam Infra& Engineering Ltd , and M/s Civil Mantra Infracon Pvt. Ltd. **The remaining bid is a single bid and decided to retender .**
