

MINUTES OF THE DEPARTMENTAL TENDER COMMITTEE HELD ON 5th May, 2025 AT 3:00 P.M. IN THE CONFERENCE ROOM OF THE MEGHALAYA P.W.D SECRETARIAT, SHILLONG.

AGENDA NO.33 Special Repair to NH-62 for the year 2024-25 under PWD(NH), Baghmara NH Division in the State of Meghalaya. (Job No.62/MG/2023-24/177):-**Allotment of work thereof.**

Tender Value: Rs. 4,33,52,186.00 (Rupees Four Crore Thirty Three Lakh Fifty Two Thousand One Hundred and Eighty Six) only (Including 12% GST)

The Brief Note and the Comparative Statement of the Financial Bids were placed before the Tender Committee and the Chief Engineer (NH), PWD(Roads) briefed the committee members that there were 2(two) bidders qualified for opening of price bid for the work viz., i) **Shri.Wilseng M Marak** & ii) **Shri. Amal Saha**. Initiating the discussion, the Chief Engineer (NH), PWD (Roads) informed the Committee that the estimate of the scheme was prepared on the basis of the Scheduled of Rates for Roads and Bridges(6th Revision – June 2018) applicable for National Highway works and SOR for Roads and Bridges and E&D Works for the year 2018-19 applicable in West, East & South West Garo Hills in Meghalaya including of GST and L.C.

As per the Ministry's guidelines for National Highway projects, tendering system has to be conducted through e-tendering. The work was put to tender in two covers bid system through e- procurement, the tender process was first initiated on 14th Feb, 2025 (At 18.00 Hrs IST) and the last date of submission of bids was on 10th March, 2025 (14:00 hrs). The Technical Bids for this project was opened on 10th March, 2025 (after 14.00 hours IST) and based on their documents, the technical bids of 2(Two) bidders for the work were found to be substantially Non- responsive. As both of the bidders are Non-Responsive, Therefore, the Committee has decided to re-tender the work .

The work was put to **re-tender** on 21st March, 2025 (At 18.00 Hrs IST) and the last date of submission of bids was on 11th April, 2025 (14:00 hrs). The Technical Bids for this project was opened on 14th April, 2025. Total 3 (Three) nos. of bidders were received through online mode in the portal of [https:// eprocure.gov.in/eprocure/app](https://eprocure.gov.in/eprocure/app), namely: 1. **Shri. Willseng M Marak** 2. **Shri. Niku Saha** and 3. **Shri. Amal Saha** . Based on their documents, the technical bids of 2(Two) bidders viz., i) Shri.Wilseng M Marak ii) Shri. Niku Saha were found to be substantially **responsive** and While iii) Shri. Amal Saha was found to be substantially **Non- responsive**. Therefore, the BEC has decided to open Financial Bids of the Technically Responsive Bidder.

The Financial Bids were opened on **25th April, 2025**. The Brief Note and Comparative Statement of the L1 & L2 Bidder has been placed before the Tender Committee. The summary of the financial bids of the substantially responsive bidder is as shown below:

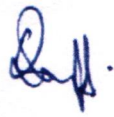
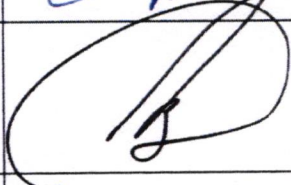
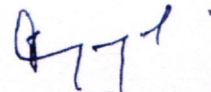
