

MINUTES OF THE DEPARTMENTAL TENDER COMMITTEE HELD ON 15TH APRIL, 2025 AT 4:00 P.M IN THE

(A) Bidding Process:- : Special Repair to NH-62 for the year 2024-25 under PWD(NH), Baghmara NH Division in the State of Meghalaya.(Job No.62/MG/2023-24/177).- **Pre Qualification thereof.**

(i) Rs. 4,33,52,186.00 (Rupees Four Crore Thirty Three Lakh Fifty Two Thousand One Hundred and Eighty Six) only
(Including 12% GST)

Consequently upon receipt of sanction from the Ministry of Road Transport and Highway, an amount of Rs Rs Rs.495.45 Lakh (Rupees Four Crore Ninety Five Lakh and Forty Five Thousand) only. Vide No. No.NH-13/8/2024-RO Guwahati (C.No.244854) dated Dt. 02. Dec. 2024. The SBD for bidding documents and Notice Inviting Tender were made available in the CPPP, MoRTH of <http://eprocure.gov.in/eprocure/app> on 14th Feb, 2025 (At 18.00 Hrs IST) and the last date of submission of Bids was upto 7th March, 2025 (14:00 hrs).

ii) The Technical bid was opened on 10th March, 2025 (14:00 hrs). Based on the documents of the bidders, the Technical Bid Evaluation Committee (BEC) examined the technical bid of the bidders as per the extant qualification criteria. After a brief discussion, the deliberation of the Departmental Tender Committee has recommend for re-tendering as both the bidders were found to be Non-Responsive.

iii) **Re-Invitation of tender:** -The work was again put to re-tender in two cover bid system through the procedure of e- procurement the process was initiated on **21st March, 2025** and the last date of submission of Bids was on **11th April, 2025** (up to 14.00 hours). The Technical bid was opened on **14th April, 2025** (after 14.00 hours IST).

(iv) **Technical Bid opening:** - The online technical bid was opened on **14th April, 2025** at 15:00 Hrs in the Office chamber of Chief Engineer (NH) P.W.D (Roads). Total 3 (Three) nos. of bidders were received through online mode in the portal of [https:// eprocure.gov.in/eprocure/app](https://eprocure.gov.in/eprocure/app), namely:

2. The Departmental Tender Committee held on 15.04.2025 at 4:00 P.M. in the Conference Hall of PWD Secretariat, Lachumiere, Shillong in presence members of Departmental Tender Committee.

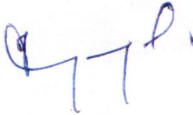
