

Minutes of the meeting held on 09.05.2025 and 14.05.2025 through VC for opening and evaluation of Bids for the work of "Consultancy Services for Project Management Unit for implementation of Land Data Asset Management Programme".

The tender for the subject work was invited by LA division of MoRTH on CPPP (Tender ID No. 2025_MORTH_854652_1) with due date as 17.04.2025 which was further extended till 01.05.2025.

2. Bid opening and evaluation committee has been constituted vide Ministry's OM No.NH-11011/80/2022-LA (Pt.2) dated 14th February, 2025 with the following members:

3. Technical bids was opened on 09.05.2025 in presence of members of evaluation committee and following 02 (Two) bidders submitted their bids on CPPP.

4. The Committee in its meeting held on 14.05.2025 decided to evaluate the Eligibility Criteria and Technical Proposals of the bidders.

4.1 Based on the document submitted by the bidders, the Committee commenced with the 1st stage of evaluation i.e Stage-A: Eligibility Criteria.

4.2 The Eligibility Criteria was examined by the Committee as per Clause 3.3.7 of the RFP.

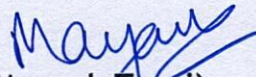
5. Member Secretary informed the Committee that the bidder M/s Nangia Anderson LLP did not meet the prescribed Eligibility Criteria i.e Profile of Firm as Firm was not registered for a minimum of 8 (eight) years as on 01.04.2024.

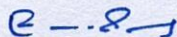
6. Member Secretary further apprised Committee that M/s Samvridhi Infotech Pvt. Limited did not meet the prescribed Eligibility Criteria i.e. Technical Capacity as Firm handled only one project with PSU i.e Mecon Ltd., in the last five years as on 1 November, 2024. As per RFP, bidder must have completed at least two projects with State Govt./ Central Govt./ PSUs/ Autonomous Bodies in the prescribed relevant field.

7. The Committee opined that both the bidders namely M/s. Nangia Anderson LLP and M/s. Samvridhi Infotech Pvt. Limited may be declared as 'Non Responsive' for the 1 stage of evaluation i.e Stage-A: Eligibility Criteria. In view of this, the Committee recommended that bid may be cancelled and re-invitation of bid may be done.

8. It was also suggested by Committee that since bidders are finding it difficult to meet the Eligibility Criteria as prescribed in RFP, therefore, Competent Authority may consider to review the RFP.
