

Minutes of the Meeting Held on 22.9.25 to finalize the Financial Evaluation of bids received for "Strengthening from km 0.00 to 13.200 (Majhola to Khatima) on NH-731k on EPC mode under Annual Plan 2025-26 in The State of Uttarakhand".

- 1- The work "Strengthening from km 0.00 to 13.200 (Majhola to Khatima) on NH-731k on EPC mode under Annual Plan 2025-26 in The State of Uttarakhand" was sanctioned vide Ministry's letter No. RO/UK/AP/2025-26/ Haldwani/01(Com. 253262) Dt. 16.07.2025 for Rs. 30.89 Cr(Job NO. : RO/UK /NH-731-K/2025-26/732 .The Civil Cost of work is Rs. 24.92 Cr. Excluding 18% GST.
- 2- The bid for above work was invited through E-tendering by Superintending Engineer, N.H. Circle, PWD, Haldwani vide letter No. 1133/12M-NH-2025, Dt 27.03.2025.
- 3- The meeting of evaluation committee chaired by Chief Engineer, NH, PWD, Dehradun on dt. in the presence of following officers:-

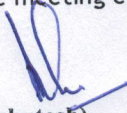

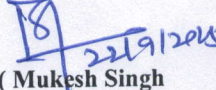
- 5- Committee found that quoted bid price of Rs 146910000.00 (Rs. Fourteen Crore Sixty Nine Lakh Ten Thousand Only) by M/s SKS Nirman Vaanijay Pvt Ltd VPO Barhana Tehsil Beri Distt. Jhajjar-124107(Haryana) is lowest and 41.05 % below from the estimated cost. Thus the committee declared that M/s SKS Nirman Vaanijay Pvt Ltd VPO Barhana Tehsil Beri Distt. Jhajjar -124107 (Haryana) as the selected bidder.
- 6- The committee directed to Superintending Engineer, N.H. Circle, PWD, Haldwani to issue LOA in the name of M/s SKS Nirman Vaanijay Pvt Ltd VPO Barhana Tehsil Beri Distt. Jhajjar-124107(Haryana) before taking justification and track record and do the further action for contract formation. It is also directed to take Additional performance security as the bid is 41.05% below.
