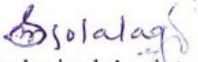

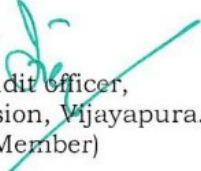

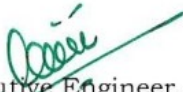
With the above details the technical bids of the said, One bidder has been placed before the technical bids evaluation committee the Member Secretary for kind approval.

After detailed verification of the documents w.r.t. above qualification criteria the Executive Engineer has tabulated the Responsive and Non responsive bidders.

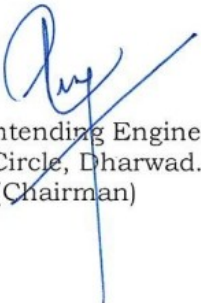
Considering all above, the evaluation committee verified all above details of bidder found that, As per Approved Daft Tender Schedule(DTS) and Tender Notification (NIT), **1)** Tender Processing Fee is Rs.5900.00 should be paid in the form of Demand Draft (DD) ,But bidder submitted only Rs.900.00 original Demand Draft (DD) & **2)** As per clause-13 Earnest money deposit (EMD) should be Validity up to 14.09.2025 i.e 135 days (90 +45 days) from last date of bid submission.But bidder submitted 5 days short fall Bank Guarantee (EMD) having validity up to 09.09.2025. Hence, the bidder shri.Dilip kumar.Saklecha is consider as Non-Responsive. Therefore, evaluation committee directed to the Executive Engineer, NH Division, Vijayapura to recall the tender (Call-3).
