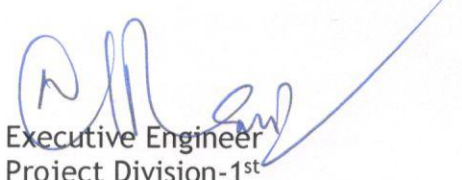

Minutes of the 2nd Evaluation Committee meeting held on 25.08.2025 at 04:30 PM for evaluation of technical bids received for the work "Construction of VUP (Vehicle Underpass) at Moominabad Intersection, underpass at Nowgam Railway Road and FOB (Foot Over Bridge) at Children Hospital on Srinagar Bypass NH - 44 in the UT of J&K under Road Safety Works on EPC mode." 2. The bids for the subject work were invited vide NIT/Tender Id No. 2025_MoRTH_856909_1 dated 16.04.2025. The amount put to tender is Rs 31.52 Cr. (including utility shifting & excluding GST). The last date for submission of bids on CPP portal was 27.05.2025.

3. The Evaluation Committee has been constituted as per Ministry vide No. RW INH-24035/4/2008-P&M/PIC Vol.II dated 23.02.2018 for evaluation of bids for NH Works in the UT of J&K being implemented by state PWD. Accordingly, the committee has been framed vide No. CE/RBK/WS/01-04 dated 22.05.2025. Details of members is appended at Annexure-I.

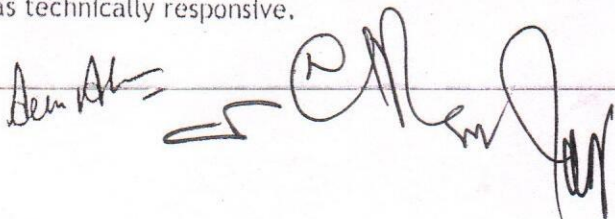
4. The technical bids for the subject work were opened on 29.05.2025 at Chief Office PWD (R&B) Central Kashmir in the presence of committee members. Total 08 no of bids were received by the Bid Due Date on CPP portal. During the technical opening, it was decided to open technical bid of 08 bidders as per clause 3.1.1 of RFP. The details of 08 Bidders are as follows:

5. The 1st meeting of Evaluation Committee was held on 04.08.2025 under the chairmanship of Chief Engineer PWD (R&B) Central Kashmir for evaluation of technical Bids received for the subject project. The bids were evaluated in accordance with the provisions of the RFP. The initial result of the technical evaluation was displayed on the web portal for a period of 07 (seven) days to invite objections, from 08.08.2025 to 14.08.2025, as per the following:

6. During the objection period, this office received two representations from M/s Tarmac Road & Roof Builders, vide letters No. TAR/Tender/11 dated 09.08.2025 and No. TAR/Tender/12 dated 13.08.2025. In their submissions, the agency contended that there was no concealment or misrepresentation in their tender documents and requested reconsideration of their bid as technically responsive.



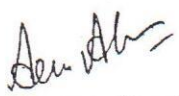
7. The Member Secretary apprised the Committee regarding representations received from M/s Tarmac Road & Roof Builders. Upon review, the Committee observed that the concerned agency had indeed not concealed or misrepresented any facts in their tender. It was therefore decided by the Evaluation Committee, to declare the bid of M/s Tarmac Road & Roof Builders, Srinagar as technically responsive.
