1.	Dhrumil Construction Co.	Did not qualify Annual financial turnover as per RFP Clause 4.3.A(a).

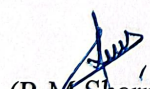

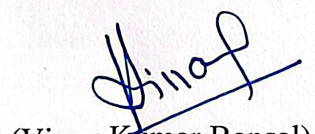

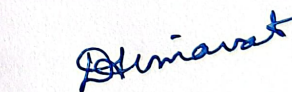
