- iii) Dipankar Mallik

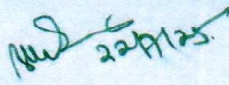

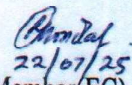

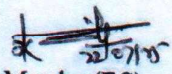
- i) Ram Chandra Paul

- iii) Dipankar Mallik

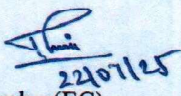
