Accordingly, the minimum annual turnover requirement for the other partner is ₹5.34 crore. However, in the documents submitted by the bidder, the financial statement of the other partner, i.e., Bari India Private Limited, for FY 2023–24 has not been provided. Consequently, the annual turnover requirement for the other JV partner has not been fulfilled. • As per Clause 13(B) of Section-1 of the RFP, the other JV partner is required to fulfill at least 30% of the eligibility criteria specified at Item 1(a) of the table under Clause 13(A). However, the JV member, Bari India Pvt. Ltd., does not meet the stipulated eligibility criteria with respect to experience in Detail Project Report (DPR) / Feasibility Study-cum-Preliminary Design Report for 2/4/6**-laning/bridge projects of aggregate length equal to two times or more of the similar category, nor does it meet the experience requirement for Project Supervision / Independent Engineer / Consultant for 2/4/6**-laning/bridge projects of aggregate length equal to three times or more of the similar category. Hence the Bidder is Considered as non-responsive as per clause 13(A) & 13(B) of the RFP.	Non-Responsive

In addition, the bidder has not fulfilled the 50% requirement related to experience in Project Supervision/Independent Engineer /Consultant services for 2/4/6-laning or bridge projects of an aggregate length equal to three times or more of the similar category. • As per Clause 13(B) of Section-1 of the RFP, the other JV partner is required to fulfill at least 30% of the eligibility criteria specified at Item 1(a) of the table under Clause 13(A). However, the JV member, Agnitio Infrastructure Projects Pvt. Ltd., does not meet the stipulated eligibility criteria with respect to experience in Detail Project Report (DPR) / Feasibility Study-cum-Preliminary Design Report for 2/4/6**-laning/bridge projects of aggregate length equal to two times or more of the similar category. Hence the Bidder is Considered as non-responsive as per clause 13(A) & 13(B) of the RFP.	Non-Responsive
