The financial offer received online of the qualified bidders were viewed and the results are as under.

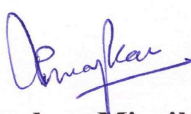
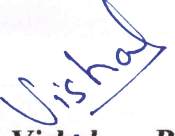
