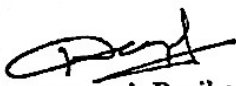

- II. Financial Bids of the 3 Nos. (Three) eligible bidders were opened on Ministry's portal on 16.06.2025 and the relevant document downloaded from Ministry's portal & same are enclosed. The details of financial bids received are as under:-

SCF-126, Opp. Sukhraj Cinema, Rose Garden Complex, GT Road, Bathinda-151001 (PB) which is 41.42% Below on sanctioned civil work cost (based on NH Circle Bikaner BSR 28th June-2024 put to tender).

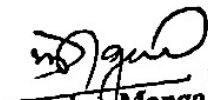
