I. NIT No. 01/2025-26 Dated 21.04.2025 issued by SE (NH) PWD Circle Bikaner

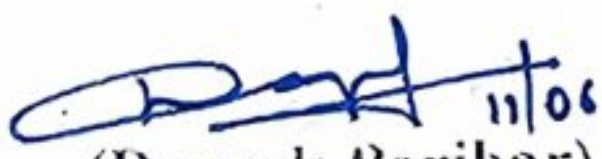

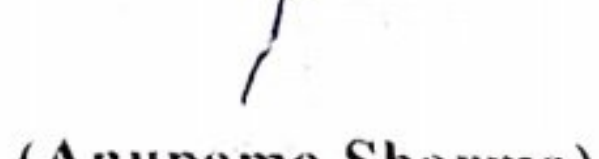
