The EMD shall be paid in the form of Bank Guarantee/FDR drawn in favour of the Executive Engineer, National Highway Division Tumkur obtained from any Nationalized/Scheduled Banks payable at Tumkur. Scanned copy of BGs or FDRs shall be uploaded along with bid documents in e- portal in the prescribed format only with a minimum validity period of 135 days (90+45) from the last date of submission of bids.

Tender document fee of Rs.2000/- shall be remitted through **'BHARATHKOSH' portal** towards payment of cost of Bid document [PAO (NH), Bangalore code no.034807 and SE, Bangalore code no: 234809 Purpose: sale of tender documents] through online payment only.
