

2nd Minutes of Meeting of the Bid Evaluation Committee held on 25.09.2025 for selection of "Consultancy Services for Supervision of Construction of 4 Lane Raniganj By-Pass of length 5.261 Km on NH-60 (New NH-14) from Km 275.20 of NH-60 to Km 478.18 of NH-2 (New NH-19) in Paschim Bardhaman, West Bengal in EPC Mode (Job No. 014-WB-2022-23/514) in the State of West Bengal" [Tender Ref No. MORT&H/RO-KOL/NIT/AE/2025-26/01, dt. 30.05.2025 and CPP Portal Tender ID No. (2025_MORTH_862485_1)].

Meeting of Bid Evaluation Committee was held on 25.09.2025 under the chairmanship of the Regional Officer, Kolkata, MoRTH through VC. The Chairman, Evaluation Committee welcomed all the Members and requested Member Secretary to elaborate the evaluation carried out for selection of Consultancy services for Authority Engineer (AE) for the project mentioned above.

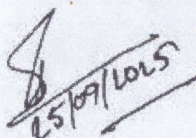

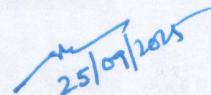
- (i) Team Leader of all the bidders scored more than 75%.

(iii) The brief evaluation sheet of all the bidders and their key personnel are placed at Annexure-I and Annexure-II.

(4) The Member Secretary apprised the Committee that after the 1st meeting of the Bid Evaluation Committee on 12.09.2025 declaring the result of Technical evaluation. The minutes of the meeting were uploaded on 16.09.2025 on the CPP portal for comments, if any.

(5) The Technical Evaluation was uploaded on 16.09.2025 & representations were submitted by 2 (Two) bidders (a) TPF Engineering Pvt. Ltd. (b) Mspark Futuristics & Associates.

(a) Mspark Futuristics & Associates submitted in his representation vide letter dated 16.09.2025 regarding consideration of result of technical evaluation that as per evaluation submitted by themselves the firm should score 96.76 in total. However, after further examination with the provisions as per RFP, the total marks of Mspark Futuristics & Associates is found unaltered from the previous uploaded result.

(b) TPF Engineering Pvt. Ltd. submitted in his representation vide letter dated 19.09.2025 regarding consideration of result of technical evaluation that NHAI has debarred M/s. TPF Engineering Pvt. Ltd. on 09.06.2025. TPF Engineering Pvt. Ltd. has contested the debarment before the Hon'ble High Court of Delhi. As per Cl. 10.3 under GCC of RFP, upon declaration of non-performer, the AE will not be able to participate in any bid for National Highways projects with MoRTH or its executing agencies till such time the debarment persists, or the AE is removed from the list of non-performers. In bidding for a particular project, bids from only such firms should be considered for placement of contract, which are neither debarred on the date of opening of tender nor debarred on the date of issue of Letter of Acceptance (LoA). Contracts concluded before the issue of the debarment / declaration as non-performer order shall, not be affected by the debarment order(s) issued subsequently. In view of the above, M/S TPF may be taken as Non-responsive.

(6) Hence, the Evaluation Committee endorsed the previously declared result for Technical Bid evaluation as mentioned below: -
