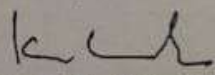


MINUTES OF MEETING OF TECHNICAL EVALUATION COMMITTEE HELD ON 16-10-2025 FOR THE WORK "Land Slide Mitigation including Slope Stabilization at Km 316/880 to Km 317/250 near Nigulsari and Km 330/350 to Km 330/560 near Nathpa on NH-05 in the State of Himachal Pradesh."

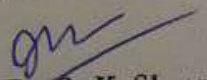
1. The work has been sanctioned by the MoRT&H vide letter no. NH-12037/28/2025/HP/North-I (comp no.- 248853) dated:- 30.03.2025 for Rs. 54.37 Crore and bids for the said work were invited vide letter no. PW-CE-NH-CTR-Tender Notice/EPC-73/2025-1012-19 dated:-02.06.2025 for the First time, which were opened on 18.07.2025.
2. The meeting of the Evaluation Committee for the evaluation of technical Bids for the work of "Land Slide Mitigation including Slope Stabilization at Km 316/880 to Km 317/250 near Nigulsari and Km 330/350 to Km 330/560 near Nathpa on NH-05 in the State of Himachal Pradesh." was held on 16.10.2025.
3. The Committee noted that a total no. of six bids have been received for the work and out of the six bidders, five bidders have uploaded their Technical bids on BIMS portal and one bidder M/s Pioneer Foundation Engineers Private Limited has not uploaded his bid on BIMS portal. Further as per the evaluation of bids on BIMS portal, the bidders have been found non-responsive and further it was observed that it happened due to the reason that the bidders have not entered the data correctly. Since Ministry has made it mandatory to evaluate the bids online on BIMS Portal, the Committee deliberated the issue and keeping in view the urgency of the work, the Committee decided to carry out the manual technical evaluation for the bids.
4. The Committee noted that the Bank Guarantee/Surety Bond/Demand draft submitted towards bid security by the 6 bidders have been confirmed from the respective banks and is found to be correct and in order.
5. The Committee deliberated the technical evaluation as per evaluation criteria mentioned in the tender documents. The outcome of technical evaluation is as below:

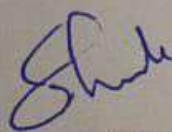

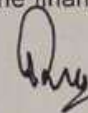

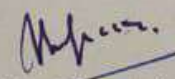

MINUTES OF MEETING regarding to discuss on the representation bidders held on 24-11-2025 for the work of "Land Slide Mitigation including Slope Stabilization at Km 316/880 to Km 317/250 near Nigulsari and Km 330/350 to Km 330/560 near Nathpa on NH-05 in the State of Himachal Pradesh."

1. The work has been sanctioned by the MoRT&H vide letter no. NH-12037/66/2025/HP/North-I (comp no.-248853) dated 30.03.2025 for Rs. 54.37 Crore.
2. Six bidders participated in the bidding process. The technical evaluation of the bids was conducted on dated 16-10-2025(Annexure-I). Three No. bidders were found technically qualified and three No. bidders i.e. M/s Bharat Constructions (India) Pvt. Ltd., M/s Maccaferri Infrastructure Pvt. Ltd., and M/s Pavai Infra Geotech, were found to be technical non-qualified in accordance with Clause 2.2.2.2(iii)(c) of RFP and.
3. Thereafter two No. bidders M/s Spar Geo Infra Private Limited, and M/s Pioneer Foundation Engineers Private Limited, have submitted the representation and they have submitted objection to the technical qualification of bidder M/s Shiva Structures Pvt. Ltd., as per Clause 2.2.2.2 (ii) of RFP and M/s Bharat Constructions (India) Pvt. Ltd., & M/s Pavai Infra Geotech, have submitted the representation and requested that their technical bids may be re-checked for the subject cited above.

The committee deliberated the representations and after deliberation found that:-

4. M/s Spar Geo Infra Private Limited, and M/s Pioneer Foundation Engineers Private Limited, vide letter No. SPAR/PWDNH/2025-26/113 dated 18-10-2025(Annexure-II)& PFEPL/MORTH/2025/04 dated 23-10-2025 (Annexure-III) vide which they have represented that the bidder M/s Shiva Structures Pvt. Ltd., does not satisfactorily demonstrate compliance with key technical requirements, specifically the installation of 3000kj flexible rockfall barriers with a minimum executed height of 70.0 meters. In this regard it was discussed that during the evaluation a clarification was sought from the bidder M/s Shiva Structures Pvt. Ltd. on 22.09.2025 (Annexure-IV) regarding the height of fixing of Rock Fall Barrier of minimum energy absorption of 3000KJ above track level certified by Authority Engineer not below the Rank of Executive Engineer, in reply to which M/s Shiva Structures Pvt. Ltd. through email dated 25.07.2025 (Annexure-V) submitted the certificate issued by EE, SMVDSB(P), Katra bearing office letter no. EE/SB/Proj./25-26/729 dated, 24.09.2025 (Annexure-VI) in which it was mentioned that "Rock Fall Barrier with minimum energy absorption capacity of 3000KJ (or above) has been fixed at a height of 75 mtr. above track level". Further to assured the certificate submitted by M/s Shiva Structures Pvt. Ltd. in reply to clarification was sent for verification to EE, SMVDSB(P), Katra on his official email on 08.10.2025 (Annexure-VII) and was also contacted telephonically in reference to which the reply was received from EE, SMVDSB(P), Katra through return email on 09.10.2025 (Annexure-VIII) and an attested copy of the certificate dated 24.09.2025(Annexure-IX) issued by his office on 11.10.2025 through email in addition to return email. But based on their representations concerning the technical qualification of M/s Shiva Structures Pvt. Ltd. Chief Engineer(NH) had sought necessary clarification (Annexure-X) from EE, SMVDSB(P), Katra and confirmation from the Chief Executive Officer and Deputy Chief Executive Officer of SMVDSB regarding the experience claimed by M/s Shiva Structures Pvt. Ltd. for the work titled "Protection / treatment work on slopes of track between Katra & Bhawan (Phase-III)." A copy of clarification sought was also sent to THDCIL (Annexure-XI). In response, a reply from consultant THDC India Limited (Annexure-XII) has also been received wherein they submitted that the day to day supervision is being done by the

team of Executive Engineer of SMVDSB. Hence any information/clarification may be obtained from Executive Engineer, SMVDSB and reply was received from the Assistant CEO, SMVDSB (Annexure-XIII) confirming the correctness of the experience certificate with the statement regarding the "height of rock fall barrier having an energy absorbing capacity of 3000 KJ or More above the track level".

M/s Spar Geo Infra Pvt. Ltd., 2nd and 3rd Floor, WZ-92C, Raja Garden, Ring Road, New Delhi - 110015, vide letter No. SPAR/PWDNH/2025-26/115 dated 10.11.2025 (Annexure-XIV) again submitted a representation wherein it was stated that, as per the information available on the official web portal of Karnataka Power Corporation Limited (KPCL)- a Government of Karnataka undertaking M/s Shiva Structures Pvt. Ltd. has debarred for a period of three years with effect from 17.12.2024 vide letter No. EECK/Debarment Notice/861 dated 17-12-2024 (Annexure-XV). Accordingly, the Technical Director, Karnataka Power Corporation Limited (KPCL) Government of Karnataka & the Executive Engineer (Civil) Kargal- Karnataka Power Corporation limited Kargal through email dated 11.11.2025 (Annexure-XVI) & 15.11.2025 (Annexure-XVII) was requested to confirm the authenticity of the aforementioned letter. In response, reply received from Executive Engineer (Civil) Kargal Karnataka Power Corporation limited Kargal through email dated 19-11-2025 (Annexure-XVIII) vide which he has confirmed that letter No. EECK/Debarment Notice/861 dated 17-12-2024 was issued from this office in which M/s Shiva Structures Pvt. Ltd. was debarred for a period of three years with effect from 17-12-2024. M/s Shiva Structures Pvt. Ltd. shall continue to remain debarred from participation in KPCL tenders.

Simultaneously, M/s Shiva Structures Pvt. Ltd. vide email dated 13.11.2025 (Annexure-XIX) has requested to clarify his position with regard to the fresh representation and blacklisted/debarred by Karnataka Power Corporation Ltd. (KPCL). M/s Shiva Structures Pvt. Ltd. vide email dated 15-11-2025 (Annexure-XX) has submitted that the Hon'ble High Court of Karnataka at Bengaluru vide order dated 19th August, 2025 in the Writ Petition No. 15609 of 2025 has quashed the impugned order bearing No. EECK/Debarment Notice/861 dated 17-12-2024.

The tender case was sent to District Attorney O/o Engineer-in-Chief, HP.PWD, Shimla to convey necessary legal opinion. District Attorney O/o Engineer-in-Chief, HP.PWD, Shimla opined that "The email as received from KPCL nowhere states anything about the action taken by the corporation consequent upon judgment passed by Karnatka High Court as relied on behalf of M/s Shiva Structures Pvt. Ltd. The said information may be obtained, as the Judgment is also subject to appeal etc. The eligibility of a bidder is to be seen at the time of submission of the bid, and if a bidder is not eligible at the time of submission for any reason as per tender document, the subsequent eligibility acquired by the bidder cannot be considered."

After deliberation, the Committee decided to reject the bid of M/s Shiva Structures Pvt. Ltd. on account of the undertakings regarding blacklisting submitted by the contractor in the bid submitted on 17.07.2025 (Annexure-XXI) for the concerned tenders. M/s Shiva Structures Pvt. Ltd. was under debarment for a period of three years w.e.f. 17.12.2024 vide KPCL order No. EECK/Debarment Notice/861 dated 17.12.2024. Although the contractor submitted the High Court order dated 19.08.2025 quashing the debarment, it may be noted that M/s Shiva Structures Pvt. Ltd. was debarred for a period of three years with effect from 17-12-2024 and also during submission of bid (i.e., 17.07.2025). Accordingly, the committee observed that the firm didn't provide correct details regarding blacklisting and so, the bid of M/s Shiva Structures may be rejected as per clause CI 2.6 of RFP and further action may be taken as per the relevant clause of the RFP.

5. M/s Bharat Constructions (India) Pvt. Ltd., vide letter No. nil dated 22-10-2025 (Annexure-XXII) vide which he has represented that we are fulfilling all the required criteria as per clause 2.2.2.2 (iii) (c) for which we has submitted sufficient certificates and request you to kindly provide us the reason on which grounds we are not qualifying the required criteria.

Based on the bidder representation the technical bid was again checked by the Committee and it was found that there was no project in the bid satisfying all the criteria in a single work i.e. minimum arch of treatment, height of flexible Rockfall barrier and energy absorption capacity of flexible Rockfall barrier as mentioned in the RFP clause 2.2.2.2(iii)(c).

Hence, committee decided to reject the representation of M/s Bharat Constructions (India) Pvt. Ltd.

- i. M/s Pavai Infra Geotech, vide letter No. Pavai/Gen./2025-26/265 dated 21-10-2025 (Annexure-XXIII) vide which he has represented that we meet the eligibility criteria and we respectfully request a clear explanation under Clause 2.2.2.2 (iii)(c) specifying the Grounds for our disqualification.

Based on the bidder representation the technical bid was again checked by the Committee and it was found that there was no project in the bid satisfying the minimum height criteria for flexible Rockfall Barrier as mentioned in the RFP Clause 2.2.2.2 (iii) (c).

In view of above, the committee has decided to open the financial bids of the following bidders:-

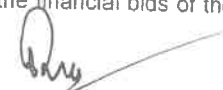

Dear Sir/Madam,

With reference to the technical evaluation uploaded on portal dated 17th Oct 2025 (Enclosed Annexure I), we hereby submit our detailed objection to the technical eligibility assessment of M/s. Shiva Structures Pvt. Ltd.

Upon review of the certificate (Annexure II) submitted by the bidder, we observe that the information provided does not sufficiently demonstrate compliance with Clause 2.2.2.2 (ii) of the RFP. This clause specifically requires experience in executing hill slope protection works, including similar landslide treatment projects with the following minimum specifications in single similar project:

- Area of 3,040 sqm (25% of project area),
- Use of Self-Drilling Rock Anchors (SDRA) / Anchor bolts with fully threaded hollow bars,
- Installation of High Tensile Rolled Cable Net (minimum 100 kN/m tensile strength), and
- Flexible Rockfall Barrier of **3000 kJ capacity for a minimum height of 70.0 meters.**

Our Objections Are as Follows:

1. Non-Compliance with 70.0 m Height Criterion:

- Based on our site visit to the reference project cited by M/s. Shiva Structures Pvt. Ltd., we observed that the maximum height of the installed rockfall barriers is approximately **40–50 meters**, which falls short of the 70.0 m requirement stipulated in the RFP.
- We are enclosing herewith relevant tender documents and drawings chainage-wise, clearly indicating the actual installed heights of each rockfall barrier section. (Annexure III & IV)

2. Request for Verification from Supervisory Authority (THDC):

As the project was a BOQ-based tender under the supervision of **THDC India Limited (THDCIL)**—appointed by the **Shrine Board** as the DPR consultant and supervisory authority for SMVD—THDCIL was responsible for identifying vulnerable locations and advising on technical remedial measures. In this context, we respectfully request that the Evaluation Committee kindly **seek formal confirmation and validation from THDCIL**, including the **as-built drawings**, to verify the actual scope, technical parameters, and compliance of the executed work.

The certificate submitted by the bidder does not satisfactorily demonstrate compliance with key technical requirements, specifically the installation of 3000 kJ flexible rockfall barriers with a minimum executed height of 70.0 meters. 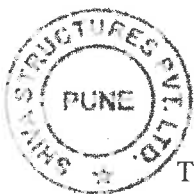
1. ACKNOWLEDGEMENT OF KPCL ORDER AND SUBSEQUENT LEGAL PROCEEDINGS

KPCL had issued a debarment order against our firm, M/s. Shiva Structures Pvt. Ltd., under Order No. EECK/Debarment Notice/861 dated 17/12/2024, debarring us from participating in future KPCL tenders for a period of three years. However, we would like to inform your good office that the said debarment order was **immediately challenged before the Hon'ble High Court of Karnataka, Bengaluru, by filing a writ petition.**

2. CURRENT LEGAL STATUS - DEBARMENT ORDER QUASHED BY HON'BLE HIGH COURT

We are pleased to inform you that the Hon'ble High Court of Karnataka has **quashed and set aside** the above-mentioned KPCL debarment order after examining the facts and merits of the case.

Details of the Judgment



- **Case Title:** M/s. Shiva Structures Pvt. Ltd. vs. Karnataka Power Corporation Ltd.
- **Case No.:** Writ Petition No. 15609 of 2025 (NC: 2025 : KHC:32095)
- **Court:** Hon'ble High Court of Karnataka at Bengaluru
- **Date of Judgment:** 19th August 2025

The Hon'ble High Court has held that the KPCL order suffers from violations of principles of natural justice - particularly non-compliance with Rule 26A (3) of the KTPP Rules, which mandates a reasonable opportunity and personal hearing before blacklisting. Consequently, the impugned debarment order has been **quashed in entirety**. Accordingly, **there is no operative debarment**

against our company from KPCL or from any other authority. We remain fully eligible and qualified to participate in all tenders and ongoing procurements without any restrictions.
(A certified copy of the judgment is enclosed for ready reference.)

3. SUPPORTING DOCUMENT ENCLOSED

Copy of Judgment dated 19/08/2025 of the Hon'ble High Court of Karnataka, Bengaluru, quashing KPCL Debarment Order No. EECK/Debarment Notice/861 dated 17/12/2024.

4. EFFECT OF THE COURT ORDER

The three-year blacklisting imposed by KPCL **no longer exists** and has **no legal force or applicability**. For all practical and legal purposes, the debarment is treated as **non-existent**.

5. COMPLIANCE WITH RFP - SECTION 4

Since the debarment order has been set aside by the Hon'ble High Court, **no action under Section 4 of the RFP** is attracted or applicable to M/s. Shiva Structures Pvt. Ltd.

We are fully compliant with all eligibility, integrity, and qualification criteria prescribed under the RFP.

CONCLUSION AND REQUEST

We hope the above clarifications, along with the enclosed judgment, satisfactorily address all concerns raised by your office. In view of the current legal position, we most respectfully request your good office to kindly:

- Consider our bid strictly on merits, and
- Proceed with evaluation without reference to the quashed KPCL order.

We remain grateful for your understanding and look forward to your positive consideration.

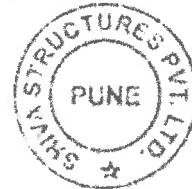

**ORAL ORDER**

Challenging order bearing no.EECK/Debarment Notice/861 dated 17.12.2024 passed by respondent no.3 at Annexure-A, this writ petition is filed.

2. Sri Showri H.R., learned counsel for petitioner submitted that petitioner is a Private Limited Company registered under Companies Act, 2013, carrying on business as a promoters, builders, contractors, construction and maintenance of all types of buildings and special township projects/developmental works. It was submitted, respondent no.3 had invited tenders for work of *"Shotcreting to U/s face, Deep pointing to D/s face and Drilling and grouting to Reach-1 from Ch: 150 to 1100' of Linganamakki Dam"* and *"Shotcreting to U/s face, Deep pointing to D/s face and Drilling and grouting to Reach-II from Ch: 3130' to 4500' of Linganamakki Dam"* vide NIT No.KPCL/2022-23/DA/WORK INDENT 13439 Dtd: 08/02/2023 & NIT No.KPCL/2022-23/DA/WORK INDENT 13438 Dtd:08.02.2023.

3. It was submitted in pursuance of same, petitioner had submitted bid and was declared as L1 bidder. At time of submission of bid, petitioner had submitted Joint Venture



Agreement ('JVA', for short) with M/s. Pioneer Foundation Engineers Private Limited ('PFEPL', for short) in order to demonstrate experience. It was submitted, respondent no.3 had earlier invited tenders in respect of same work in year 2020 and 2022. While applying for said tender, petitioner had also produced JVA with PFEPL, but due to oversight a different version of JVA was uploaded. On ground that there was discrepancy in JVA submitted earlier and JVA submitted in year 2023, respondent no.3 had issued a notice to petitioner seeking clarification. Petitioner had submitted detailed reply as per Annexure-D.

4. It was submitted, despite clarification, petitioner was issued with show cause notice dated 15.03.2024 as per Annexure-E proposing debarment/black listing. Even to same, petitioner submitted reply on 30.03.2024 as per Annexure-F. Without considering reply, respondent no.3 proceeded to pass impugned order at Annexure-A under Section 14A of Karnataka Transparency in Public Procurements Act, 1999, ('Act', for short) debarring petitioner from participating in future tenders for period of three years from date of order. Aggrieved thereby, this writ petition is filed.



5. Main ground urged by learned counsel for petitioner was that Hon'ble Supreme Court in case of **Kulja Industries Limited v. Chief General Manager, Western Telecom Project Bharat Sanchar Nigam Limited and Others**, reported in **(2014) 14 SCC 731**, had elaborated principles governing blacklisting and which were referred to by this Court in W.P.no.35902/2024 disposed of on 17.04.2025 highlighting need for fair play and opportunity prior to blacklisting. Relying upon same, it was submitted that impugned order was liable to be quashed on ground of violation of principles of natural justice.

6. On other hand, Smt.Vaheeda, learned Additional Government Advocate for respondent no.1 and Sri Kiran Kumar V. Sambrani, learned counsel for respondents no.2 and 3 opposed writ petition.

7. Learned counsel for respondents no.2 and 3 submitted that upon issuing notice at Annexure-E, petitioner had submitted its reply as per Annexure-F. Perusal of Annexure-F would reveal that petitioner admitted discrepancy insofar as JVA with PFEPL dated 23.11.2016. While JVA submitted in tenders of year 2020 and 2022 indicated sharing

ratio at 80% by petitioner and 20% by PFEPL, while JVA uploaded in pursuance of tender notification of year 2023 shared ratio to be at 60:40, indicating that petitioner had submitted tampered documents while submitting bid. It was submitted, action taken by respondents was strictly as per Rule 26A of Karnataka Transparency in Public Procurements Rules, 2000, ('Rules', for short) read with Section 14 of Act. Therefore, no interference was warranted.

8. Heard, learned counsel and perused writ petition.

9. From above, petitioner's challenge against order of debarment at Annexure-A is principally on ground of violation of principles of natural justice. Rule 26A (3) of Rules, specifically provides for reasonable opportunity including oral hearing to concerned for making representations against proposed action to be given by Debarment Committee. Apparently impugned order at Annexure-A does not indicate compliance with said requirement. On said ground alone, impugned order at Annexure-A passed by tender authority requires to be set-aside. Hence, following:

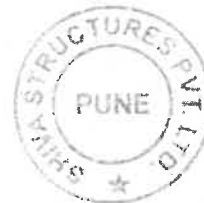
