At the onset, Chief Engineer (NH) Haryana welcomed the participants. The Executive Engineer, National Highway Division, PWD B&R Br., Bhiwani apprised that the technical, administrative and financial sanction of the instant work was accorded for Rs.614.00 Lacs by MoRT&H vide letter No.RW/RO-CH-W(36)-HR-2024 dated 27.03.2025. According to the sanction letter, the work was to be executed on EPC mode. The Competent Authority has approved RFP document for amounting to Rs.483.81 Lacs (Excluding GST) with time lime of 12 (twelve) months vide Head office memo No.49188 on dated 16.04.2025. Accordingly, the tender was invited by the E.E. NH Division, Bhiwani on dated 23.04.2025 on standard bidding document of MoRT&H duly vetted by competent authority with estimated project construction cost Rs.483.81 Lacs (Excluding GST). The last date of receipt of bids was 05.06.2025 but only single tender of M/s Kisan Construction Company was received and being a single tendering agency on first time invitation of bid, tender could not be opened.

Further, the tender was re-invited by EE NH Division, Bhiwani on dated 10.06 2025 on standard bidding document of MoRT&H duly vetted by competent authority with estimated project construction cost Rs.483.81 Lacs (Excluding GST). It was apprised that the process of invitation of RFP was done online through Central Public Procurement Portal as per the guidelines. The last date of receipt of bids was 09.07.2025.

2 (two) number bidders uploaded their technical bids online on Central Public Procurement Portal (CPPP) upto bid due date 09.07.2025, the details are as under :-
