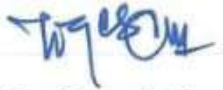

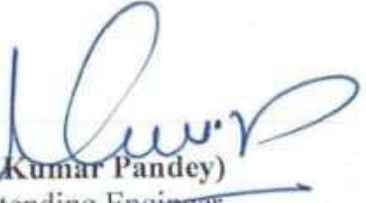


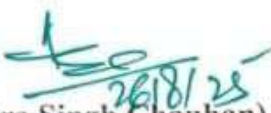
5. Member secretary informed that all the necessary/requisite documents of all above bidders have been verified as per RFP at division level.

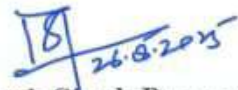
