1. The meeting of the Evaluation Committee was held on dt. _____ in the Chamber of the Chief Engineer(World Bank), Nirman Bhavan, Ground Floor, opp New Sachivalay Gandhinagar for the evaluation of technical bids for the Construction of New Major Bridge over Purna River near Viraval between km 363/360 to km 364/360 of NH 64 in Navsari district in the state of Gujarat on Engineering Procurement and Construction EPC Mode (Job No. 64/GJ/ 2024- 25/773).The following committee members were present.

2. At the outset, the Chief Engineer(World Bank), Nirman Bhavan, Ground Floor. Opp New Sachivalay Gandhinagar, welcomed the members. The Committee was apprised that a total of 04(Four) bids were received and opened through the MoRTH online portal on **Dt.07-11-2025**. All the 04(Four) bids were uploaded through the MoRTH <https://eprocure.gov.in> portal. The details of Bidders are as under.

The documents of technical bids of the 04(Four) bids received through the MoRTH <https://bims.gov.in> portal and <https://eprocure.gov.in> were downloaded and the technical evaluation was done based on the bid documents submitted on the <https://eprocure.gov.in> portal. Since Technical Evaluation through MoRTH<https://bims.gov.in> portal is not functional at present, the evaluation of technical bids are prepared manually and placed at Annexure-II.

6. The evaluations of the technical bids were conducted by the Evaluation Committee and based on the technical evaluation, the Evaluation Committee decided to declare the following 04(Four) bidder **technically responsive** as per the pre-qualification criteria given in the RFP documents in EPC mode.
